This letter confirms our commitment to examine the health care costs associated with firearm injuries in the United States, particularly the extent to which public payers, such as Medicaid, bear the cost of these injuries, on the basis of your letter to the Comptroller General. As discussed with your staff on October 21, 2020, we plan to complete our work and send a draft product to the agency for comment during the spring of 2021. Terms of Work

Objectives/Key Questions

In this study, we will examine the health care costs associated with firearm injuries. Our key questions are:

- 1. Describe initial hospital costs associated with firearm injuries in the United States and specifically the costs for Medicaid and Medicare.
- 2. Describe additional health care services that may be required for survivors of firearm injuries, and what is known about the costs associated with these services.

Scope and Methodology

To describe the initial hospital costs associated with firearm injuries, we will obtain, review, and analyze inpatient and emergency department data from the Agency for Healthcare Research and Quality (AHRQ)'s Healthcare Cost and Utilization Project (HCUP). We will produce nationally representative estimates of the prevalence of initial hospital visits for firearm injuries and the costs associated with those visits. We will examine prevalence and costs by a number of variables, including payer type, injury severity, injury site, geographic location, discharge status, demographic characteristics, and hospital characteristics.

To describe additional health care services that may be required for survivors of firearm injuries and what is known about the costs of these services, we will take several steps. We will conduct literature reviews of peer-reviewed articles and government reports on (1) the costs associated with longer-term health care services for survivors of firearm injuries and (2) longer-term service use associated with firearm injuries. We will also work with the National Academies to select 12-15 experts to participate in virtual expert panel discussions on (1) the types and amounts of longer-term health care services that may be required for survivors of different firearm injuries and factors affecting the level of care provided and (2) the state of existing research on longerterm health care costs for firearm injuries, including any limitations or data gaps, as well as a more general discussion of what is known about these costs.

The work will be done in accordance with generally accepted government auditing standards.

Reporting on Status of Our Work

We will periodically discuss the status of our work with you and/or your staff.
