18	"(B)(i) Not later than one year after the date of the
19	enactment of this subsection, the Secretary of Defense

22	beginning on July 1, 1943, and ending on December 31,
23	1948, a discharge from such service under honorable con-
24	ditions if the Secretary determines that the nature and
25	duration of the service of the individual so warrants.
