Dear Secretary Mayorkas and Administrator Criswell:

We write in strong support of Massachusetts' latest FY 2024 application for Federal Emergency Management Agency (FEMA) Shelter and Services Program<sup>1</sup> (SSP) funding.

Today, Massachusetts applied for \$34.5 million in SSP funding to provide new arrivals in the state with shelter and related humanitarian services. SSP funding is urgently needed in Massachusetts.<sup>2</sup> Currently, 7,377 families live in the state's shelters — almost double the shelter population as of March 2023.<sup>3</sup> Just over half of those families are new arrivals to the United States.<sup>4</sup> The only state in the country with a "right to shelter" law, Massachusetts has struggled to house every family in need of shelter, and nearly 800 families are on a waiting list.<sup>5</sup> With shelter facilities at capacity, families have been forced to sleep outdoors and in cars, in a state with below-freezing temperatures for months of the year.<sup>6</sup> Some have turned to airport lobbies and hospital emergency rooms for makeshift shelter.<sup>7</sup> The Commonwealth is now running out of shelter funding and faces a shortfall in its shelter budget for the upcoming fiscal year.<sup>8</sup>

We recognize that the total pool of SSP funding is inadequate. We fought to secure SSP funding for the Commonwealth, pushing Congress to appropriate sufficient SSP funding,<sup>9</sup> and urging FEMA to allocate a fair share to Massachusetts.<sup>10</sup> Ultimately, Congress appropriated \$650 million for SSP, successfully defeating House Republicans' demands to defund SSP altogether.<sup>11</sup> But this is less than the \$800 million appropriated last year — and significantly less than the \$1.4 billion that President Biden requested, or the billions that we and local leaders around the country have called for.<sup>12</sup> Of that \$650 million in SSP funding, FEMA has already allocated \$275 million to states, and will now award \$340.9 million in SSP-C funding through a competitive process (with millions more still in reserve).<sup>13</sup>

While we continue to advocate for more funding, it is important to note that the SSP funding that Massachusetts has received to date has been a lifeline for the state's shelters, but has not come close to meeting the Commonwealth's needs. This year, Massachusetts was allocated nearly \$7

million of the allocated SSP grant funds (SSP-A).<sup>14</sup> While this is more than triple the \$1.9 million the Commonwealth received in 2023, it hardly makes a dent in the over \$900 million that the Commonwealth expects to spend on shelter in the upcoming fiscal year.<sup>15</sup>

We thus urge FEMA to fulfill the Commonwealth's entire request for \$34.5 million from the pool of competitive SSP grant funds. Additional SSP funding is critical to ensure that Massachusetts receives an equitable share of funding that reflects the financial costs the Commonwealth is incurring. Meanwhile, we will continue to fight for additional federal funding for communities hosting new arrivals.

As the Commonwealth stands by its values and continues to welcome new arrivals, the state needs more federal funding to respond to a national trend of increased immigration.<sup>16</sup> We thus ask you to promptly approve Massachusetts' application for \$34.5 million in SSP-C funding.
