Dear Majority Leader Schumer, Minority Leader McConnell, Chairman Durbin, and Ranking Member Grassley:

On behalf of the past presidents of the Massachusetts Black Lawyers Association (MBLA), we proudly and enthusiastically support the nomination of Suffolk County District Attorney Rachael S. Rollins to serve as the United States Attorney for the District of Massachusetts. Ms. Rollins' commitment to public service is evident through her current role serving as the District Attorney of Suffolk County in Massachusetts, her prior roles serving as Chief Legal Counsel to the Massachusetts Port Authority, the General Counsel to the Massachusetts Department of Transportation and the Massachusetts Bay Transportation Authority, and as an Assistant United States Attorney for the District of Massachusetts. We are confident that Ms. Rollins is well-suited to take on this role, and given her breadth of professional and personal experiences, Ms. Rollins will have an immediate and positive impact as the next United States Attorney for the District of Massachusetts.
