Dear Mr. Bannon,

We write today to seek clarification on your recent communications with Breitbart News Network, as well as to better understand your compliance with Executive Order 13770 and other federal ethics regulations.

As you know, President Trump signed Executive Order 13770 on January 28, 2017.<sup>1</sup> The order requires "[e]very appointee in every executive agency appointed on or after January 20, 2017" to sign and be "contractually committed to" an "Ethics Pledge." Among other provisions, the Ethics Pledge prevents appointees from "participat[ing] in any particular matter involving specific parties that is directly and substantially related to [their] former employer or former clients" for the first two years after their appointment.<sup>2</sup> The Executive Order states that, a "particular matter involving specific parties" includes "any meeting or other communication relating to the performance of one's official duties with a former employer."<sup>3</sup> As an employee of the Executive Office of the President, you are subject to the requirements outlined in Executive Order 13770.<sup>4</sup>

In addition, you are subject to federal ethics regulations issued by the U.S. Office of Government Ethics ("OGE").<sup>5</sup> Among other requirements, OGE regulations require executive branch employees to "avoid an appearance of loss of impartiality in the performance of...official

duties."<sup>6</sup> To maintain the appearance of impartiality, executive branch employees are prohibited by 5 C.F.R. § 2635.502 from "participat[ing] in...a particular matter" if they "know that a person with whom [they have] a covered relationship is or represents a party." Executive branch employees are considered to be in a "covered relationship" with individuals "for whom the employee has, within the last year, served as officer, director, trustee, general partner, agent attorney, consultant, contractor or employee."<sup>7</sup>

Given the clear restrictions on communicating with former employers outlined in Executive Order 13770, as well as regulatory requirements that you "maintain the appearance of impartiality" regarding your former employers, we were concerned to hear about your recent communications with Breitbart News Network ("Breitbart"), where you formerly served as the Executive Chairman.<sup>8</sup> On February 14, 2017, Breitbart published what has been described as "an extensive attack" on Reince Preibus, President Trump's Chief of Staff.<sup>9</sup> You told news outlets that you "went ballistic" on a phone call with Breitbart's Washington political editor, Matthew Boyle, to protest this article.<sup>10</sup> Later that week, you reportedly "instructed [Boyle] not to publish additional articles critical of Preibus," which reportedly spurred the White House to offer Boyle "access to key staffers," including Press Secretary Sean Spicer, then-Deputy Chief of Staff Katie Walsh, and President Trump himself.<sup>11</sup> In March, Breitbart's Editor in Chief, Alex Marlow, told reporters that you "reach out" to him "every so often."<sup>12</sup>

Your communications with Breitbart appear to violate the Ethics Pledge outlined in Executive Order 13770. Because they relate to news coverage of the Trump Administration, your conversations appear to qualify as "communication[s] relating to the performance of [your] official duties with a former employer." In addition, because you left your position at Breitbart less than one year ago, these communications appear to be in clear violation of both the pledge and OGE regulations. While the executive order, as well as OGE regulations, permit the White House to waive ethics requirements in specific circumstances,<sup>13</sup> the White House has publicly

confirmed that you have not received a waiver to communicate with Breitbart.<sup>14</sup> It is unclear whether you have received a waiver under 5 C.F.R. § 2635.502.

To help us better understand your compliance with executive branch ethics requirements, please provide us with answers to the following no later than April 28, 2017:

- 1. Did you sign an Ethics Pledge, as outlined in Executive Order 13770? If so, please provide a copy of your signed Ethics Pledge.
- 2. Upon signing an Ethics Pledge, did you receive any guidance from the Office of Government Ethics ("OGE") or the Office of the White House Counsel regarding the protocols for compliance with the Ethics Pledge? If so, please provide copies of that guidance, if written guidance was made, or descriptions, if guidance was provided verbally.
- 3. Did you seek or receive an opinion from the Office of Government Ethics or the Office of the White House Counsel's office, prior to any of your communications with Breitbart news, determining whether your communications with Breitbart would violate Executive Order 137700 or 5 C.F.R. § 2635.502? If so, what was their determination?
- 4. Have you received a waiver from Executive Order 13770, or an authorization under 5 C.F.R. § 2635.502, to allow you to talk to any individuals affiliated with Breitbart News?
- 5. Were you disciplined by the Office of the White House Counsel, following your communications with Breitbart, for violating the Ethics Pledge or for violation 5 C.F.R. § 2635.502? If so, please provide a description of the consequences of violating the Ethics Pledge.
