Dear General Miller:

I write to request clarification on the safety and security of United States servicemembers in the wake of recent reports that Russia's military intelligence unit (GRU) covertly offered and made payments to Taliban-linked militants to kill American soldiers in Afghanistan.<sup>1</sup>

Numerous public reports reveal that the Russian government offered bounties to kill American soldiers in Afghanistan,<sup>2</sup> which included the use of a "key [Afghan] middleman who for years handed out money from a Russian military intelligence unit to reward Taliban-linked fighters for targeting American troops."<sup>3</sup> Additionally, information gained from U.S. Special Operations Forces (SOF) raids in Afghanistan suggested that the existence of this Russian bounty program was in circulation "in early 2019,"<sup>4</sup> raising questions about whether this alleged

scheme was directly connected to attacks that resulted in the deaths of U.S. troops.<sup>5</sup> United States SOF are presently in Afghanistan advising the Afghan Special Security Forces on building their counter-terrorism capacity,<sup>6</sup> and will therefore continue to be in harm's way despite the limited scope of their mission. The operation of a Russian-bankrolled bounty program to kill U.S. and coalition forces would be a brazen use of proxy forces to harm American lives. The reports therefore raise questions about the activities of Special Operations Command that led to the discovery of this alleged scheme and the steps subsequently taken to protect U.S. special operators on the ground in Afghanistan.

I am deeply concerned about credible threats to the safety and security of U.S. servicemembers. Given the seriousness of the alleged Russian-bankrolled scheme to kill our military personnel in Afghanistan, I request answers to the following questions by July 16, 2020:

- 1. Did raids, interrogations, or other operations by U.S. SOF lead to the discovery of information suggesting the existence of a Russian-funded bounty program to offer and make payments to Taliban-linked militants to kill U.S. servicemembers? If yes, what did you find about this alleged program?
  - a. Did you share what you found with any U.S. officials, including those from the White House, the Department of Defense, the Department of State, and the Intelligence Community (IC)? If yes, please name those officials.
  - b. Did you share what you found with your counterparts in other countries that are part of coalition forces in Afghanistan?
  - c. Did you share what you found with Afghan National Security Forces?
- 2. If you shared information suggesting the existence of a Russian-funded bounty program with appropriate U.S. intelligence agencies, what more did you learn about the alleged program after those agencies had performed their analyses and assessments?
- 3. Has the alleged Russian-funded bounty program contributed to attacks on any U.S. or coalition forces? If so, please provide additional information on these attacks and any casualties.
- 4. What additional force protection measures, if any, did you or your subordinates implement to enhance the protection of U.S. forces under your command after learning of information suggesting the existence of a Russian-funded bounty program? Please describe when such steps were taken.
- 5. Have any operations by the forces under your command been modified in response to information suggesting the existence of a Russian-funded bounty program to kill U.S. soldiers, and if yes, how?

Thank you for your attention to this matter.
