Dear Mr. Perry:

I am writing to follow up on our previous correspondence¹ regarding your ethically questionable decision to rejoin the board of directors of Energy Transfer, the company responsible for the Dakota Access Pipeline and other controversial infrastructure projects² and a company that lobbied the Department of Energy while you were Energy Secretary.³ Recent reports have also indicated that, while serving as Energy Secretary, you used your position at the Energy Department to push for deals that "advanced the business interests of [your] friends and political allies" including Energy Transfer. ⁴ These reports come less than a year after I sent you and Energy Transfer's chief executive officer Kelcy Warren letters earlier this year urging you to resign from Energy Transfer's board of directors due to concerns about corruption and conflicts of interest.⁵ Your actions raise even more questions about your behavior during you time in government service, including your "alleged role in helping President Trump pressure Ukraine to investigate his political rivals," and are a clear example of the need for Congress to pass my Anti-Corruption and Public Integrity Act. 7

As Energy Secretary for the first two years of the Trump administration, you were one of the chief architects in planning and executing the federal government's energy policy, notably "aggressively promot[ing] President Trump's fossil fuel agenda" and "energetically trumpet[ing] oil and gas development while overseeing plans to reduce funding for wind, solar and other forms of renewable energy." You were responsible for numerous agency actions to weaken environmental protections and suppress climate science as part of the Trump administration's anti-climate policy agenda, in addition to previously calling to eliminate the Energy Department while running for president in 2012. You also worked steadfastly to boost the fossil fuel industry, even to the point of absurdly claiming that fossil fuels can help prevent sexual assault. 11

The policies you oversaw directly benefitted the fossil fuel industry, including Energy Transfer and its role building and promoting controversial fossil fuel infrastructure. ¹² In October 2019, you announced your resignation as Energy Secretary and left office less than two months later. ¹³ Within weeks of leaving office, you were appointed as a director of the general partner of Energy Transfer. ¹⁴ This was a lucrative move for you; you are reportedly eligible for an "annual retainer of \$100,000 as well as annual stock awards worth up to \$100,000 in value" in your new role. ¹⁵ New filings with the Securities and Exchange Commission now show that "three months after leaving government, [you] owned Energy Transfer shares currently worth around \$800.000." ¹⁶

Prior to your confirmation as Energy Secretary, various reports outlined your potential conflicts of interest between serving as a board member for Energy Transfer and its subsidiary Sunoco prior to serving as Energy Secretary, particularly given your close ties to the fossil fuel industry and its political arms. ¹⁷ According to reports, "[your] involvement with [Energy Transfer], which is building the controversial Dakota Access Pipeline, had drawn attention as a potential conflict of interest after Trump tapped [you] for the Cabinet post." Reports further detailed close political ties between you and Energy Transfer, as well as its CEO Kelcy Warren. During your 2016 presidential campaign, "[a]t the same time [you] sat on the [Energy Transfer] board, [Energy Transfer] CEO Kelcy Warren poured millions of dollars into [your] political ambitions... [and] chipped in \$6 million to super-PACs backing [you]." New reports show that during your tenure at the Energy Department, you "worked to advance energy deals that were potentially worth billions of dollars to [your] friends and political donors," including a deal "worth an estimated \$20 billion." Ethics experts have stated that your efforts "were violations of federal regulations" because "[a]dministration officials are not allowed to participate in matters directly relating to companies on whose board they have recently served." ²¹

These findings appear to contradict your recusal statement, signed on March 3, 2017, and made public through a Freedom of Information Act (FOIA) request on November 18, 2019, where you stated that you "have a 'covered relationship' with Energy Transfer Partners, L.P.," and that you "[would] not participate personally and substantially in any particular matter involving specific parties in which [you] know [Energy Transfer] is a party or represents a party for a period of two years." I am concerned that, given your decision to rejoin Energy Transfer's board immediately after resigning from federal public service and your tenure overseeing the weakening of environmental protections that may benefit your political allies in the fossil fuel industry, you may have used your time as Energy Secretary to benefit your former business affiliates, political allies, and future benefactors.

This is exactly the kind of unethical, revolving-door corruption that has made Americans cynical and distrustful of the federal government. I have introduced far-reaching ethics

legislation, the *Anti-Corruption and Public Integrity Act*, which would prevent senior government officials from spinning through the revolving door by prohibiting corporations like Energy Transfer from hiring or compensating the Energy Secretary, or any other senior government official from an agency that Energy Transfer lobbied in the past two years.²⁴

I intend to keep working to make that proposal law. As I urged you to do in January, however, you should rectify your mistake and immediately resign from your position on the board of directors of Energy Transfer. Doing so would send a strong and necessary message about government ethics and your own integrity, which you have already tarnished through your actions before, during, and after your time in the Trump administration.
