Dear Secretary Raimondo:

I write today regarding your failure to respond to a letter I sent to you on December 14, 2021, regarding a series of disturbing remarks¹ you made in a video statement to the U.S. Chamber of Commerce about potential regulation of Big Tech by European Union (EU) authorities.²

I wrote that letter because your statements appeared to undermine Administration policies on antitrust and competition. The President's Executive Order on Promoting Competition in the American Economy states that the Administration's policy is "to enforce the antitrust laws to meet the challenges posed by new industries and technologies, including the rise of the dominant Internet platforms." The Executive Order also encourages the Federal Trade Commission to use its rulemaking authority to better regulate "unfair competition in major Internet marketplaces."4

Your December statement ran counter to the Administration's antitrust efforts, and suggested that you would defend U.S. Big Tech firms from competition efforts from European allies even when those efforts are designed to achieve the same goals as the Biden Administration's policies. I wrote that, "your focus on the impact of the new EU legislation on U.S.-based tech firms and their ability to serve EU customers reads as a rush to defend the market share and profits of giant multinationals," and that, "Big Tech now wants to run the same play and preempt legitimate antitrust, anti-disinformation and misinformation, pro-worker and pro-consumer regulation by

writing new international rules. They should not be able to rely on you to run interference for them."⁵

My concerns about your activities and views on competition policy have only increased as reports indicate that the Commerce Department continues to lobby the EU on these policies. Reports indicate that one of your top aides has lobbied a member of the European Parliament leading work on relevant EU legislation, including repeating arguments "previously used by Apple in particular." I am deeply troubled by this report and your failure to respond to the questions in my December letter, more than two months after it was sent.

The table below contains the questions that I asked in my December letter, and your responses. It reveals that you failed to answer any of my questions about the extent to which you are undermining Administration competition policies.
