Dear Ms. Bellon and Dr. Williams:

I am writing to express my support for the food service workers of UNITE HERE Local 100 (Unite Here) as they take the next step in negotiating a new contract. For more than a full year, these workers – who perform critical food service work in the Federal Reserve Bank of New York (NY Fed) facility – have been attempting to negotiate a new contract with their employer Sodexo Group (Sodexo). Now that Sodexo will reportedly be joining Unite Here at the bargaining table tomorrow, I urge Sodexo to negotiate in good faith with its workers and to reach a contract that guarantees them a livable wage. Furthermore, I urge the NY Fed to utilize all tools at its disposal as Sodexo's client to guarantee these workers a fair and just contract.

Reports indicate that after cancelling bargaining earlier this month, Sodexo will resume negotiations on a new contract with its workers. Since NY Fed food service workers' previous collective bargaining agreement with Sodexo expired in February 2022, they have faced an uphill battle as they have sought to negotiate a new contract. The process culminated in a unanimous vote last week to authorize a strike that finally brought Sodexo to the bargaining table in earnest. Workers' primary demand – and a key driver of the strike vote – has been an increase in their minimum wage to \$20 per hour to account for the rise in the cost of living since their last wage increase in March 2021. I am glad that Sodexo has reportedly committed to meeting workers' demand for a \$20 per hour minimum wage, but it is critical that this commitment be reflected in a competitive collective bargaining agreement.

Sodexo is not alone in its obligation to engage productively with its food service workers: as Sodexo's client and the facility in which these workers perform their jobs, the NY Fed has the tools and the institutional mandate to help address their concerns. The NY Fed can express its
