Dear Senator Warren and Representative Min,

In response to your letter dated December 3, 2025, we wanted to share information on our long history of supporting important public works projects. For more than 30 years, Amazon has invested in American communities and made contributions that reflect our continued commitment to celebrating America's future, including our recent contribution in support of the White House Ballroom project. Notably, among other efforts, Amazon is a sustaining member of the Smithsonian and has contributed to the National Museum of African American History and Culture, the National Museum of American History, the National Museum of African American Music, and the Stonewall National Museum.

With respect to your questions, we communicated with the fundraising group working on the White House Ballroom project beginning in August 2025, where we discussed potential giving amounts and the dinner planned for donors. We worked directly with the Trust for the National Mall to coordinate our payment, and attended the White House program commemorating the launch of the project on October 15, 2025. We did not review any construction plans or enter into an agreement related to the donation. Amazon chose to be listed as a donor because we remain committed to supporting projects that celebrate and promote our nation's heritage.
