Re: Response to December 3, 2025 Letter to Comcast Corporation

Dear Senator Warren, Senator Duckworth, Representative Holmes Norton, Representative Takano, Representative Carson, Representative Ansari, Representative Min, Senator Blumenthal, Representative Johnson, Jr., Representative Watson Coleman and Representative Goldman:

On behalf of Comcast Corporation and its affiliated entities (collectively “Comcast” or “the Company”), I write in response to your December 3, 2025 letter concerning donations made toward the construction of a new ballroom on White House grounds. We hope you find the information helpful.

As part of its continuing commitment to philanthropy in the Washington, DC region, Comcast recently pledged an unrestricted donation to the Trust for the National Mall, a nonpartisan 501(c)(3) tax-exempt entity dedicated to restoring, preserving, and enriching the National Mall and the White House grounds. Since 2007, the Trust for the National Mall has served as a nonprofit partner of the National Park Service, financing vital public works projects in part through private donations. Comcast’s pledged donation included no specific limitations or conditions on how the proceeds were to be used or spent. Furthermore, Comcast made the donation with no expectations of receiving anything in return and the implication that the donation has anything to do with a potential transaction involving Warner Brothers Discovery is categorically false.

Comcast’s donation is in keeping with its extensive history of philanthropic efforts in and around the Washington, DC region. Comcast is invested in promoting the vibrant civic life of the nation’s capital as well as a wide variety of Washington institutions. To that end, Comcast has contributed to a range of charitable entities, including: the Smithsonian National Museum of the American Latino, the D.C. Public Library Foundation, the Congressional Black Caucus Foundation, Upward Thrive Academy, Rosie Riveters, Catholic Charities DC, the National Archives, the Trump Vance Inaugural Committee, the Biden Inaugural Committee, the Town Hall Education Arts Recreation Campus, New Hope Community Outreach Services, DC Dream Center, and the Sasha Bruce Youth Network. Comcast looks forward to promoting and deepening its partnerships with these organizations and others in the future.
