To promote ethics and prevent corruption in Department of Defense contracting and other activities, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.

- 4 (a) SHORT TITLE.—This Act may be cited as the
- 5 "Department of Defense Ethics and Anti-corruption Act6 of 2019".

3 "(c) DUPLICATE INFORMATION NOT REQUIRED.— An annual report submitted by a contractor pursuant to 4 5 subsection (b) need not provide information with respect to any former officer or employee of the Department of 6 7 Defense or former or retired member of the armed forces 8 if such information has already been provided in a pre-9 vious annual report filed by such contractor under this 10 section.

''(d) DEFINITIONS.—In subsection (b)(3), the terms
'client', 'lobbying activities', 'lobbying contact', and 'lobbyist' have the meanings given the terms in section 3 of
the Lobbying Disclosure Act of 1995 (2 U.S.C. 1603).".

(b) EFFECTIVE DATE.—The amendments made by
subsection (a) shall take effect on the date of the enactment of this Act, and shall apply with respect to contracts
entered into on or after that date.

# 1SEC. 103. COMPTROLLER GENERAL REPORT ON POST-GOV-2ERNMENT EMPLOYMENT OF FORMER DE-3PARTMENT OF DEFENSE OFFICIALS.

4 Not later than 90 days after the date of the enact-5 ment of this Act, the Comptroller General of the United States shall initiate a review updating the information and 6 7 findings contained in the May 2008 Government Accountability Office report entitled, "Defense Contracting: Post-8 9 Government Employment of Former DOD Officials Needs Greater Transparency" (GAO-08-485). The Comptroller 10 11 General shall provide an interim briefing on the status of 12 the review to the congressional defense committees not 13 later than December 31, 2020, with a report to follow by 14 a date agreed upon with the committees.

#### FORCEABLE ON CERTAIN CONTRACTS.

17 (a) PROHIBITION.—

18 (1) IN GENERAL.—Any contract for the pro-19 curement of goods or services, other than a contract 20 for the procurement of commercial products or serv-21 ices, with a value of excess of \$10,000,000 shall in-22 clude a contract clause prohibiting the contractor 23 from providing compensation to a former Depart-24 ment of Defense official described in paragraph (2) 25 within four years after such former official leaves 26 service in the Department of Defense.

1 (2) COVERED DEPARTMENT OF DEFENSE OFFI-2 CIAL.—An official or former official of the Depart-3 ment of Defense is covered by the requirements of 4 this section if such official or former official is a 5 former officer or employee of the Department of De-6 fense or a former or retired member of the Armed 7 Forces who served as a program manager, deputy 8 program manager, procuring contracting officer, ad-9 ministrative contracting officer, source selection au-10 thority, member of the source selection evaluation 11 board, or chief of a financial or technical evaluation 12 team for a contract with a value in excess of 13 \$10,000,000, and such person— 14 (A) participated in the contract or license 15 selection; 16 (B) determined or signed off on the tech-17 nical requirements of the contract or license; or 18 (C) granted the contract or license. 19 (b) ADMINISTRATIVE ACTIONS.—In the event that an 20 official or former official of the Department of Defense 21 described in subsection (a)(2), or a Department of De-22 fense contractor, knowingly fails to comply with the re-23 quirements of this subsection, the Secretary of Defense 24 may take any of the administrative actions set forth in

#### 3 SEC. 105. BAN ON HIRING SENIOR OFFICIALS BY GIANT DE-

#### FENSE CONTRACTORS.

5 (a) PROHIBITION.—

6 (1) IN GENERAL.—Any Department of Defense 7 contract for the procurement of goods or services 8 with a giant defense contractor shall include a con-9 tract clause prohibiting the contractor from hiring or 10 paying (including as a consultant or lawyer) any cov-11 ered Department of Defense official within four 12 years after such former official leaves service in the 13 Department of Defense.

14 (2) DEFINITIONS.—In this section:

15 (A) COVERED DEPARTMENT OF DEFENSE
16 OFFICIAL.—The term "covered Department of
17 Defense official" means a former officer or em18 ployee of the Department of Defense or a
19 former or retired member of the Armed Forces
20 who served—

21 (i) in an Executive Schedule position
22 under subchapter II of chapter 53 of title

4 SEC. 106. MODIFICATION OF PROHIBITION ON LOBBYING 5 **ACTIVITIES WITH RESPECT TO THE DEPART-**6 MENT OF DEFENSE BY CERTAIN OFFICERS 7 OF THE ARMED FORCES AND CIVILIAN EM-8 PLOYEES OF THE DEPARTMENT OF DEFENSE 9 FOLLOWING SEPARATION FROM MILITARY 10 SERVICE OR EMPLOYMENT WITH THE DE-11 PARTMENT.

(2) A former direct competitor or client of any
organization for which the officer or employee has
served as an employee, officer, director, trustee, or
general partner in the past 4 years.

(3) Any employer with whom the officer or em ployee is seeking employment.

3 (b) CONSTRUCTION.—Nothing in this section shall be 4 construed to terminate, alter, or make inapplicable any 5 other prohibition or limitation in law or regulation on the 6 participation of officers or employees of the Department 7 of Defense in covered matters having an effect on their 8 or related financial or other personal interests.

9 (c) COVERED MATTER DEFINED.—In this section,
10 the term "covered matter"—

(1) means any matter that involves deliberation,
decision, or action that is focused upon the interests
of specific person or a discrete and identifiable class
of persons; and

(2) includes policy making that is narrowly focused on the interests of a discrete and identifiable
class of persons.

18 SEC. 108. PROHIBITION ON OWNERSHIP OR TRADING OF

19STOCKS IN CERTAIN COMPANIES BY DEPART-20MENT OF DEFENSE OFFICERS AND EMPLOY-21EES.

22 (a) PROHIBITION ON OWNERSHIP AND TRADING BY
23 CERTAIN SENIOR OFFICIALS.—

24 (1) PROHIBITION.—An official of the Depart25 ment of Defense described in paragraph (2) may not

6 (2) DEPARTMENT OF DEFENSE OFFICIALS.— 7 An official of the Department of Defense described 8 in this paragraph is any current Department of De-9 fense official described by section 847(c) of the Na-10 tional Defense Authorization Act for Fiscal Year 11 2008 (10 U.S.C. 1701 note).

12 (3) NATURE OF OFFENSE.—Ownership or a
13 trade of a stock in violation of paragraph (1) is an
14 offense under section 208 of title 18, United States
15 Code.

16 (b) PROHIBITION ON OWNERSHIP AND TRADING BY 17 ALL OFFICERS AND EMPLOYEES.—An officer or employee 18 of the Department of Defense may not own or trade a 19 publicly traded stock of a company that is a contractor 20 or subcontractor of the Department if the Office of Stand-21 ards and Compliance of the Office of the General Counsel 22 of the Department of Defense determines that the value 23 of the stock may be directly or indirectly influenced by 24 any official action of the officer or employee for the De-25 partment.

(c) INAPPLICABILITY TO MUTUAL FUNDS.—For pur poses of this section, publically-traded stock does not in clude a widely-held investment fund described in section
 102(f)(8) of the Ethics in Government Act of 1978 (5
 U.S.C. App.).

8 SEC. 201. ANNUAL REPORTS ON APPROVAL OF EMPLOY-9 MENT OR COMPENSATION OF RETIRED GEN-10 ERAL OR FLAG OFFICERS BY FOREIGN GOV-11 ERNMENTS FOR EMOLUMENTS CLAUSE PUR-12 POSES.

13 (a) ANNUAL REPORTS.—Section 908 of title 37,
14 United States Code, is amended—

15 (1) by redesignating subsection (c) as sub-16 section (d); and

17 (2) by inserting after subsection (b) the fol-18 lowing new subsection (c):

19 "(c) ANNUAL REPORTS ON APPROVALS FOR RE-20 TIRED GENERAL AND FLAG OFFICERS.—(1) Not later 21 than January 31 each year, the Secretaries of the military 22 departments shall jointly submit to the appropriate com-23 mittees and Members of Congress a report on each ap-24 proval under subsection (b) for employment or compensa-25 tion described in subsection (a) for a retired member of

ADVISING FOREIGN GOVERNMENTS. 23 Section 207(f) of title 18, United States Code, is 24 amended-

3	(2) by inserting after paragraph $(2)$ the fol-
4	lowing new paragraph:
5	"(3) PERMANENT RESTRICTION WITHOUT

7	"(A) IN GENERAL.—Any person who has
8	been employed as a senior official in the White
9	House, the Department of State; the Depart-
10	ment of Defense, or the Department of the
11	Treasury who, without the explicit prior ap-
12	proval of the Secretary of State, performs com-
13	pensated work for a foreign entity that might
14	benefit from the knowledge obtained by the per-
15	son as a result of such United States Govern-
16	ment employment, shall be punished as pro-
17	vided in section 216 of this title.
18	"(B) LIMITATION ON APPROVAL.—The
19	Secretary of State may not approve any work
20	described in subparagraph (A) that conflicts
21	with the national security interests of the
22	United States, as determined by the Secretary
23	and verified by the Director of National Intel-
24	ligence.

1 "(C) ANNUAL REPORT.—The Secretary of 2 State shall submit an annual report listing all 3 of the approvals under subparagraph (A) dur-4 ing the prior calendar year to the Committee on 5 Foreign Relations of the Senate, the Committee 6 on Armed Services of the Senate, the Select 7 Committee on Intelligence of the Senate, the 8 Committee on Foreign Affairs of the House of 9 Representatives, the Committee on Armed Serv-10 ices of the House of Representatives, and the 11 Permanent Select Committee on Intelligence of 12 the House of Representatives.". 13 SEC. 203. BAN ON FORMER MILITARY AND CIVILIAN INTEL-14 LIGENCE OFFICERS FROM FOREIGN EMPLOY-15 MENT. 16 (a) IN GENERAL.—Except as provided in subsection 17 (b), military and intelligence officers possessing a security 18 clearance, upon separation from service or resignation, are 19 prohibited from obtaining employment with a foreign gov-20 ernment or a private company doing work predominantly 21 on behalf of a foreign government. 22 (b) EXEMPTION.— 23 (1) IN GENERAL.—Employment with the Gov-24 ernment of Australia, of Canada, of New Zealand, or

of the United Kingdom is not subject to the prohibi tion under subsection (a).

3 (2) WAIVERS.—Individuals may seek and be 4 granted a waiver by the Secretary of State for em-5 ployment by any other foreign government. Such 6 waiver will be presumptively granted in cases that 7 ex-officers seek employment in jobs focused on hu-8 manitarian aid, development, or infrastructure im-9 provement. Waivers for employment in other jobs 10 shall be determined based on whether such employ-11 ment would reasonably involve the use or disclosure 12 or appropriation of sources, methods, or skills that 13 could pose a threat to United States' interests when 14 employed by other countries or enable the repression 15 of the nationals of such countries.

## 17SEC. 301. AFFIRMATIVE CONTRACTOR RECORD DISCLO-18SURES.

19 The Secretary of Defense shall publish on a publicly 20 available Internet website the following information to the 21 extent such information is unclassified and non-confiden-22 tial:

(1) In the case of a contract with the Depart-ment of Defense for goods or services above the sim-

1	plified acquisition threshold specified in section 134

3	(A) copies of each contract and task deliv-
4	ery order the contractor on such contract has
5	entered into with the Department of Defense
6	during the previous three fiscal years; and
7	(B) past performance information about
8	the contractor to the extent it is maintained by
9	the Department.
10	(2) In the case of a contract with the Depart-
11	ment of Defense for goods or services in excess of
12	\$10,000,000, all correspondence and documents re-
13	lated to the contract.
14	(3) The contractor report required under sec-
15	tion 2410t of title 10, United States Code, as added
16	by section 102 of this Act.
17	SEC. 302. EXTENSION OF FOIA TO PRIVATE CONTRACTORS.
18	(a) DEFINITIONS.—In this section—
19	(1) the term "covered contractor" means a pri-
20	vate contractor that entered into a contract with the
21	Department;
22	(2) the term "covered record" means any
23	record produced using Federal funds during the ful-
24	fillment of a Department contract by a covered con-
25	tractor; and

to subsection (a) is the information as follows:

16 (3) A biographical summary of the officer.

17 (4) Any financial disclosures made by the offi-18 cer to or for Department of Defense purposes.

19 (5) Any substantiated reports of an Inspector
20 General in the Department Defense involving con21 duct of the officer.

(6) Summaries of any command climate survey
conducted with respect to a command of the officer.
(c) REDACTION.—Information made available pursuant to subsection (a) may be redacted in a manner that
accords with the provisions of section 552a of title 5,
