## Enclosure

1. What have DoD and its subcomponents done to address security threats posed by retired veterans with knowledge of our military infrastructure working for foreign governments?

**Response:** Each of the Military Services have implemented their own processes for requesting Secretary of the Military Department review for retired veterans requesting permission for foreign government employment. These processes are similar in that they are reviewed by, at a minimum, Military Department legal counsel and the senior human resources officer or another senior leader to whom the Secretary of the Military Department has delegated approval authority, prior to forwarding to the Secretary of State for final approval. The processes to identify and address security threats posed by the prospect of such employment vary depending on the Military Service to include the process for Service-level background checks, intelligence assessments, and defensive counterintelligence recommendations, prior to being considered for approval. As of late 2022, the Department of Defense (DoD) has undertaken efforts to improve security vetting and consistency by leveraging the National Counterintelligence Task Force to facilitate interagency reviews and coordination.

2. Has DoD asked any retired officers to cease working for foreign governments after providing approval in the last 10 years?

**Response:** No. The Military Departments have not asked any retired officer to cease working for foreign governments after initial approval.

a) Please provide information about those requests including the name of the officer, the foreign country they were performing work on behalf of, the name of any contractors involved, and the job duties performed.

3. How many approvals or denials has DoD issued for retired officers seeking employment with foreign governments in the last 10 years?

**Response:** Since 2012, there have been 450 applications with 406 approvals, 12 denials, 21 applications that were administratively closed with no action or withdrawn, and 11 that are pending either Military Department review or Department of State approval.

a) Please provide information about those requests including the name of the officer, the foreign country they were performing work on behalf of, the name of any contractors involved, and the job duties performed.

**Response:** See second enclosure. Consistent with DoD practice to appropriately protect personal privacy, names of individuals in the grades of O-6 and below have been withheld.

4. How many times has the DoD withheld retirement pay and benefits because of a servicemembers' failure to receive approval for foreign work in the last 10 years?

**Response:** Two Service members have been the subject of recoupment actions for failure to adhere to the foreign government employment process.

a) Please provide information about each matter including the name of the officer, the foreign country they were performing work on behalf of, the name of any contractors involved, the job duties performed, and the amount of money saved for the taxpayer.

- 1) General Duncan McNabb; *Country:* Azerbaijan, *Name of the Contractor:* Silk Way Airlines and Ares Mobility Solutions, Incorporated; *Total Debt:* \$111,750.
- 2) Lieutenant General Michael Flynn; Country: Russia, Name of the Contractor: Russia Today; Total Debt: \$38,557.06.
- 5. Does DoD consider whether a corporation or individual's activities would raise concerns about potential violations of International Traffic in Arms (ITAR) requirements?

**Response:** The Department of State is responsible for the export and temporary import of defense articles and services governed by 22 U.S.C. § 2778 of the Arms Export Control Act and Executive Order 13637. All applications are forwarded to the Department of State for review and processing. Military retirees who apply for approval of foreign government employment are provided information regarding International Traffic in Arms Regulations (ITAR), including helpful definitions and guidance regarding how to contact the Department of State Directorate of Defense Trade Controls.

6. If the State Department flags a corporation or individual pursuant to ITAR, how does your Service take that notice into consideration?

**Response:** If the Military Departments are notified that a corporation or individual has been flagged pursuant to ITAR, such a flag would be considered as part of the Military Department's review prior to forwarding an application to the Department of State for final approval.

7. Please provide the name, rank, job duties, foreign country, any known compensation, and dates of service, for all former service members who now work on behalf of foreign nations. Which of these officials received explicit permissions to do so, consistent with 37 U.S.C. § 908?
