Dear Commissioner Bisignano,

Since President Trump took office, we have—prompted by the administration's attacks on Social Security—sent 17 letters to the Social Security Administration (SSA). These letters have sought answers for why the Trump Administration and the Department of Government Efficiency (DOGE) appear to be dismantling the SSA, potentially depriving Americans of their hard-earned benefits.

We have not received responses to the vast majority of our questions. In fact, Acting Commissioner Leland Dudek has reportedly instructed staff to not respond to public or congressional inquiries.¹ The limited answers we have received have been unsatisfactory.

We have also requested information from you directly. Through direct inquires, your hearing before the Senate Committee on Finance, and post-hearing Questions for the Record, we have sought to determine whether you intend to continue DOGE's disastrous efforts to hollow out the SSA. In response, you repeatedly claimed that, because you were not yet working at SSA, you did not have sufficient information to answer.² You made these claims despite the fact that a former SSA employee whistleblower has reported that you have been participating extensively in high-level operational, management, and personnel decisions at SSA.³ Regardless of your previous claims, though, you have now been sworn in and have access to the information you claimed you need to provide us answers.

Now that you are the confirmed head of the SSA, we are following up to demand answers to the nearly 200 questions we have sent to SSA leadership since President Trump was inaugurated. We are extraordinarily concerned about the future of the SSA under the Trump Administration, and Americans deserve information about the fate of their benefits under your watch. We

Acting Commissioner King:

We write to express deep concern that, after infiltrating the Department of Treasury's federal payment systems on January 31, 2025, associates of Elon Musk – ostensibly operating under the direction of President Trump and the "Department of Government Efficiency" (DOGE) have now obtained access to data systems at the Social Security Administration (SSA). On February 6, 2025, *Semafor* reported that DOGE is seeking to access—or have already accessed—SSA's systems.¹

As the central hub for Americans' most sensitive personal and financial information and the nation's largest benefit-paying agency, DOGE's actions represent a two-front invasion on Americans' financial security and privacy. The information collected and housed at the agency could have significant commercial value as well as competitive advantage for individuals seeking to use it for financial gain. Likewise, it could be misappropriated to target American citizens and businesses for political or exploitative means.

SSA administers the three largest federal-benefit programs, the Old-Age Survivor's Insurance, Disability Insurance, and Supplemental Security Income (SSI) program. Collectively, SSA pays over \$1.3 trillion in monthly benefits to over 70 million Americans each month. SSA also provides support to administer other federal programs and laws, including Medicare, Medicaid, SNAP, eVerify, Children's Health Insurance Program (CHIP), and the Help America Vote Act, and verifies SSNs to federal and state agencies and employers.

As such, SSA systems include the most sensitive personally identifiable information and personal health information for tens of millions of seniors, adults, and children. This includes Americans' Social Security Numbers; bank and credit card information; birth and marriage

certificates; pension information; home and work addresses; school records; citizenship status; immigration or naturalization records; health care providers' contact information; family court records; employment and employer records; psychological or psychiatric health records; hospitalization records; addiction treatment; and test for or records of HIV/AIDS. These records are handled and operated by career civil servants under stringent federal and state privacy laws and regulations to protect Americans' health and financial information. There is no reason non-government political operatives would need access to sensitive payment systems.

Federal laws protect sensitive personal and financial information from improper disclosure and misuse, including by barring disclosure to individuals who lack a lawful and legitimate need for it. We and the American public have not been made aware of any legitimate purpose for DOGE to access such information. Moreover, the Privacy Act of 1974 as amended (5 U.S.C. 552a, Public Law 93-579), protects Americans against an unwarranted invasion of their privacy related to the disclosure of their personal information. And in so doing, it requires each federal agency to publish in the Federal Register information related to how and why it is accessing a specific system of records—data that are collected, maintained, used, or disseminated that contain personally identifiable information. No justification has been published related to DOGE actions at SSA or otherwise.

Without appropriate oversight, transparency, and accountability, our nation's health care, retirement and disability systems —and the privacy of millions of Americans—are at the political whims of President Trump, Congressional Republicans, and DOGE. For this reason, we request that you respond to the following questions no later than February 14, 2025:

- 1. Has DOGE, or any individuals or entities operating under the guise of or direction of DOGE (including such individuals who may have been onboarded to the Agency and received an Agency or Departmental email address) requested and/or received access to any SSA system that is used in determining eligibility or benefit amount of Social Security or SSI benefits?
 - a. If so, who granted such access, to which systems, and for what specific purposes? Please name each system and provide the names of individuals who have been given access to such system.
 - b. Under what legal authority did SSA grant such access? Please provide a detailed description of this authority and copies of all communication between individuals associated with the "Department of Government Efficiency" and SSA systems.
 - c. For each individual who has been given access to SSA data systems since January 20, 2025, please provide information on:
 - The agency to which each such individual has been onboarded (or working as a contractor for) and whether an individual who may have been onboarded to a different agency has been given an email address for either SSA;

- ii. Which federal forms each such individual completed relating to background checks (i.e. SF-85, SF-85P, SF 85P-S, SF-86);
- iii. Whether the Federal Bureau of Investigation (FBI) completed a background check for each such individual;
- iv. Whether the individuals have used their data access privileges consistent with any restrictions based on their respective security clearance levels;
- v. What trainings on security, health information privacy, cybersecurity, financial, fraud, or other trainings required of SSA or their contractors these individuals have undertaken and when.
- d. Please provide a list of queries run on each such system by each user, since January 20, 2025, including dates and usernames.
- e. Please provide a thorough accounting of the information each individual reviewed, modified, accessed, deleted, or otherwise edited under such system.
- f. For any information that has been modified, edited, or deleted, please provide an accounting of the variables, entries, and the exact changes made, as well as for what purpose.
- g. Please provide details on any information from any such systems that were downloaded, copied, transferred, or otherwise removed from the Agency. Please specify which data, by what means they were downloaded or transferred, and to whom or what entity.
- 2. Has DOGE, or any individuals or entities operating under the direction of DOGE gained access to SSA databases that include personally identifiable information, wage or tax information, or personal health information?
 - a. If so, which data have been reviewed, modified, deleted, or otherwise edited or removed, copied, or downloaded or otherwise transferred by these individuals?
 - b. Under what legal authority did SSA grant such access? Please provide a detailed description of this authority and copies of all communication between individuals or entities operating under the direction of DOGE and SSA officials related to the granting of this access.
 - c. How many individuals does this affect? Have these individuals been notified that their information has been accessed and for what purposes in accordance with the requirements of the Privacy Act of 1974, as amended, and Section 1106 of the Social Security Act (42 U.S.C. 1306)? Please provide documentation.
 - d. To the extent personally identifiable information were accessed since January 20, 2025, please provide the System of Record Notice included in the Federal Register reflective of this access.
- 3. Have any private or commercial servers been connected or integrated into SSA data systems to review, edit, modify, access, delete, move or otherwise change data?

- a. If so, please explain the origin of such servers and provide documentation related to testing and validating controls to ensure no new vulnerabilities were introduced into SSA data systems upon use.
- b. For any data that were moved to a private or commercial server, please show how that system has been reviewed and is abiding by the National Institute of Standards and Technology (NIST) special publication 800-171, Protecting Controlled Unclassified Information in Nonfederal Systems and Organizations.²
- c. For any data that were moved to a private or commercial server, please provide detailed information related to whether any safe storage standards are being employed.
- 4. Attempts to suspend federal payments have been reportedly attempted by individuals or entities operating under the direction of DOGE.³ We are deeply concerned that DOGE may attempt to stop lawful payments for Social Security and SSI benefit payments, deny benefits to individuals who are perceived to not support President Trump, or otherwise inflict financial harm on individuals.
 - a. What steps have been taken to ensure that the data of individuals, beneficiaries, and health care providers are protected from unlawful payment suspensions or data leaks?
 - b. What specific steps have been taken to ensure compliance with current laws, guidances, and regulations to ensure that the use of these data will not interfere with timely payments of Social Security and SSI benefits?
 - c. What specific steps have been taken to ensure compliance with current laws, guidances, and regulations to ensure that personally identifiable information that is held on SSA systems is not being utilized for politically motivated purposes?

Thank you for your attention to this urgent matter. I look forward to your prompt response.

Dear Acting Commissioner King,

I am writing to express my concern regarding reports that the Social Security Administration (SSA) will be closing the White Plains, New York, hearing office on May 31, 2025, with no plans to open an alternative location.

The White Plains hearing office is located in Westchester County and provides services to constituents in seven counties, including Westchester, Rockland, Putnam, Orange, Dutchess, Ulster, and Sullivan counties. As the only hearing office in the lower Hudson Valley region, its closure will negatively impact thousands of constituents who reside in these seven counties. If SSA does not open an alternative site, beneficiaries will be required to travel between 24 and 135 miles to be serviced by the closest offices in New York City, Albany, New Jersey, and Connecticut. Travel by private vehicle or public transportation to any of these alternative locations would pose greater hardship for constituents, while also significantly increasing the costs and time associated with travel.

To date, the White Plains office has approximately 2,000 cases pending, with individuals waiting almost eight months for a redetermination hearing. Access to SSA's hearing offices is critical for those who were denied eligibility for Social Security Disability Insurance (SSDI) or Supplemental Security Income (SSI). Initial denials occur fairly frequently in the disability determination process, with many individuals receiving an initial denial and ultimately receiving approval for benefits.

Apart from the impact that this closure will have on those who are serviced by the White Plains office, I am also concerned about the employees who work at this location. At a time when President Trump is trying to gut the federal workforce, this closure would affect the staff who strive every day to provide the American people with high-quality service.

Maintaining and improving the services that SSA offers to the public is essential to ensuring that Americans can access their earned benefits. Over the past decade, SSA has faced stagnant budgets and an increasing workload, while it has also closed field offices and seen the deterioration of in-person and phone services shifting more interactions online. Specifically, since 2010, SSA's customer service budget has fallen 17 percent (adjusted for inflation) and staffing at SSA is at a 25year low. Despite this and despite pleas from Democrats in the House and Senate, Republicans have resisted increases to SSA's operational budget, and have in fact, suggested cuts. Current estimates indicate that if SSA funding is cut back below 2022 levels, the agency will be forced to lay off

additional staff and add to an already large backlog. Former Commissioner Martin O'Malley worked to rectify the issues at SSA, but change cannot be achieved overnight, and further cuts to staff and services endanger SSA and benefit delivery further.

Therefore, I urge you to consider securing an alternative hearing office location in the lower Hudson Valley and request a written response by March 3, 2025, to address the following questions and concerns:

- 1. Individuals are already waiting almost eight months for a hearing in the White Plains office. How will this closure impact wait times? What steps is the Administration taking to reduce wait times?
- 2. Given that many constituents who have open cases lack dependable internet access and are without dependable personal transportation, how will SSA facilitate hearings and related services for these constituents?
- 3. SSA already operates local field offices in Middletown, Orange County; Monticello, Sullivan County; New Rochelle and Peekskill, Westchester County; Poughkeepsie, Dutchess County; and West Nyack, Rockland County. Would SSA provide accommodations to allow constituents to participate in hearings at their closest local field office or another remote site in the lower Hudson Valley? What additional resources or funding would be needed to secure an alternative site for SSA hearings in the region?
- 4. Please share how the decision to close the White Plains hearing office was made. Did the Administration's directive to the General Services Administration to revoke all leases for federal offices nationwide have an impact on SSA's decision to close the White Plains hearing office? Does the Administration have plans to close additional SSA offices?

Acting Commissioner Dudek:

We write to express deep concern regarding disturbing reports¹ that the President replaced Social Security Administration (SSA) Acting Commissioner Michelle King for refusing to provide Elon Musk and the so-called "Department of Government Efficiency" (DOGE) access to the agency's most sensitive data without proper documentation, and that you have provided DOGE unfettered access.

As the central hub for Americans' most sensitive personal and financial information, and the nation's largest benefit-paying agency, DOGE's actions--in seeking access to this information-represent a two-front invasion on Americans' financial security and privacy. In response to earlier media reports detailing DOGE's efforts to access SSA systems, Senator Wyden demanded information from then-Acting Commissioner King to verify these reports and to understand what steps she has taken to protect Americans' privacy. In her February 11 response, she wrote that no one affiliated with DOGE had "requested nor received access to the agency's programmatic systems." Further, she stressed that employee access to SSA's systems is limited to the least privileges necessary to complete job duties, and its systems are continuously monitored to identify suspicious behaviors.

Stringent privacy laws, regulations, and administrative procedures are in place to protect American's data, including personally identifiable information, stored and used for legitimate purposes by government agencies. Maybe nowhere is that more important than SSA. For example, the Privacy Act of 1974, as amended (5 U.S.C. 552a, Public Law 93-579), protects Americans against an unwarranted invasion of their privacy related to the disclosure of their personal information. And, in so doing, it requires each federal agency to publish in the Federal Register information related to how and why it is accessing a specific system of records—data that are collected, maintained, used, or disseminated that contain personally identifiable information. To date, no justification has been published related to DOGE actions at SSA or otherwise. Providing access to personally identifiable information on hundreds of millions of Americans stored by SSA to DOGE employees without a legitimate reason, and in apparent disregard for privacy laws, regulations, and procedures, raises serious concerns about the security of that data and what DOGE plans to do with it.

We are also concerned that DOGE's access to these systems has been provided under false pretenses claiming rampant fraud to cut benefits to Americans. Over the past weekend, Elon Musk repeatedly posted and reposted a false claim that millions of individuals over age 150 are

receiving Social Security benefits. These claims are so easily disproven, and have been repeatedly, that this cannot be a justifiable reason to need complete access to all data housed at SSA. A simple internet search would show U.S. Census data estimating approximately 80,000 Americans over age 100 living in the United States today,² and SSA's own data shows that roughly 53,000 Americans over age 100 receive Social Security benefits in December 2023.³ As you know, SSA's Office of Inspector General (OIG) published an audit in 2023⁴ which found that of the 18.9 million individuals over age 100 that did not have death information reported to SSA, almost none currently receive benefit payments or have reported earnings in the past 50 years. In the same audit, SSA noted that combing through the agency's records to update the information of these individuals would cost up to \$9.7 million, with little benefit to SSA's administration of the programs.

As you know, the information collected and housed at the agency could have significant commercial value, as well as competitive advantage for individuals seeking to use it for financial gain. Likewise, it could be misappropriated to target American citizens and businesses for political or exploitative means. This includes Americans' Social Security Numbers; bank and credit card information; birth and marriage certificates; pension information; home and work addresses; school records; citizenship status; immigration or naturalization records; IRS earnings records; health care providers' contact information; family court records; employment and employer records; psychological or psychiatric health records; hospitalization records; addiction treatment; and test for or records of HIV/AIDS. These records are handled by career civil servants under stringent federal and state privacy laws and regulations to protect Americans' health and financial information.

As you well know, SSA employs sophisticated systems, processes, and controls to ensure that benefits are paid the correct amount to the correct person. SSA has made great strides in improving its program integrity systems to reduce improper payments and to prevent instances of waste, fraud, or abuse. While we agree that more can always be done to improve SSA's process, Musk and DOGE do not appear to be interested in improving the system for Americans. Rather than working collaboratively with the agency to understand and improve its existing systems, Musk and DOGE have been keener on publicizing misleading or blatantly inaccurate information about Social Security. This raises questions on whether their pursuit of combatting waste, fraud, and abuse is purely performative rather than sincere.

Moreover, the President's decision to replace a career SSA official with over three decades of agency experience with an employee with no executive experience will likely trigger a cascade of departures of experienced agency personnel, as former Commissioner O'Malley warned.⁵ At a time when the agency's workforce is at a 50-year low, the potential loss of centuries' worth of agency experience will risk worsening backlogs, longer wait times, and interruption of benefit payments. When combined with SSA providing inexperienced individuals unfettered access to the agency's sensitive systems, there is a profound risk of causing irreparable harm to the agency's systems and Americans' financial security.

Finally, we are also concerned of reports that prior to your appointment as Acting Commissioner, you were placed on administrative leave pending an investigation into you sharing sensitive documents with individuals not authorized to access such information, and for harassing and threatening fellow SSA employees to work with DOGE. If accurate, your actions demonstrate a betrayal of trust and your oath of office and may violate federal privacy laws.

For this reason, we request that you respond to the following questions no later than February 25, 2025:

- 1. Have you disclosed any personally identifiable information (PII), protected health information (PHI), federal tax information (FTI), or other sensitive personal and financial information in any SSA data systems to:
 - a. Any SSA personnel or SSA contractors who lacked the appropriate statutory authority to access such information;
 - b. Non-SSA federal employees;
 - c. Non-SSA federal contractors;
 - d. Special Government Employees (SGEs); or
 - e. Any other unauthorized persons?
- 2. Has DOGE, or any individuals or entities operating under the guise of or direction of DOGE (including such individuals who may have been onboarded to the Agency and received an Agency or Departmental email address) requested or received access to any SSA system that is used in determining eligibility or benefit amount of Social Security or SSI benefits?
 - a. If so, who granted such access, to which systems, and for what specific purposes? Please name each system and provide the names of individuals who have been given access to such system.
 - b. Under what legal authority did SSA grant such access? Please provide a detailed description of this authority and copies of all communication between individuals associated with the "Department of Government Efficiency" and SSA systems.
 - c. For each individual who has been given access to SSA data systems since January 20, 2025, please provide information on:

 - b. Under what legal authority did SSA grant such access? Please provide a detailed description of this authority and copies of all communication between individuals or entities operating under the direction of DOGE and SSA officials related to the granting of this access.
 - c. How many individuals does this affect? Have these individuals been notified that their information has been accessed and for what purposes in accordance with the requirements of the Privacy Act of 1974, as amended, and Section 1106 of the Social Security Act (42 U.S.C. 1306)? Please provide documentation.
 - d. To the extent personally identifiable information were accessed since January 20, 2025, please provide the System of Record Notice included in the Federal Register reflective of this access.
- 4. Have any private or commercial servers been connected or integrated into SSA data systems to review, edit, modify, access, delete, move or otherwise change data?
 - a. If so, please explain the origin of such servers and provide documentation related to testing and validating controls to ensure no new vulnerabilities were

- introduced into SSA data systems upon use.
- b. For any data that were moved to a private or commercial server, please show how that system has been reviewed and is abiding by the National Institute of Standards and Technology (NIST) special publication 800-171, Protecting Controlled Unclassified Information in Nonfederal Systems and Organizations.⁶
- c. For any data that were moved to a private or commercial server, please provide detailed information related to whether any safe storage standards are being employed.
- 5. Attempts to suspend federal payments have been reportedly attempted by individuals or entities operating under the direction of DOGE.⁷ We are deeply concerned that DOGE may attempt to stop lawful payments for Social Security and SSI benefit payments, deny benefits to individuals who are perceived to not support President Trump, or otherwise inflict financial harm on individuals.
 - a. What steps have been taken to ensure that the data of individuals, beneficiaries, and health care providers are protected from unlawful payment suspensions or data leaks?
 - b. What specific steps have been taken to ensure compliance with current laws, guidance, and regulations to ensure that the use of these data will not interfere with timely payments of Social Security and SSI benefits?
 - c. What specific steps have been taken to ensure compliance with current laws, guidance, and regulations to ensure that personally identifiable information that is held on SSA systems is not being utilized for politically motivated purposes?

Dear Commissioner Dudek:

I write to seek clarification regarding the circumstances under which you were name as Acting Social Security Commissioner, and troubling reports indicating that – days before President Trump named you this position – you were "placed on administrative leave pending an investigation into your sharing unauthorized access to information with representatives of Musk's U.S. DOGE Service."1

The circumstances of your appointment raise questions about the truthfulness of President Trump's assertion that "Social Security will not be touched [by DOGE]." Even before you were named as Acting Commissioner, DOGE operatives had been installed in powerful positions at the Social Security Administration (SSA).³ They have launched an attack on the agency, closing at least 10 local offices, firing scores of personnel,⁴ and gaining access to SSA internal systems. These systems contain extremely sensitive personal information belonging to millions of Americans who receive Social Security benefits, and, if DOGE officials interfere – either purposefully or accidentally – with their function, it could result in delays or disruptions to Americans' Social Security benefits.

This level of access for individuals not employed by SSA is unprecedented and alarming, and reports indicate that you played a key role in providing this access.⁵ According to public reports, former Acting Commissioner Michelle King, a career civil servant, resigned on February 16th after refusing to allow Elon Musk's DOGE team full access to the agency's systems.⁶ Like Ms.

King, you are a career civil servant at SSA. However, unlike Ms. King, you appear to have facilitated DOGE officials' access to the system. According to a report by the Wall Street Journal, you "had been sharing information with nonagency personnel beginning in December, before Trump's inauguration, and ... pressured [career staff] to help DOGE representatives." Leaders at SSA were reportedly so concerned about your behavior that they placed you on administrative leave pending an investigation into your efforts on DOGE's behalf. You even appear to have corroborated reports of your misbehavior, writing in a now-deleted LinkedIn post:

I confess. I helped DOGE understand SSA. I mailed myself publically [sic] accessible documents and explained them [sic] DOGE. I confess. I moved contractor money around to add data science resources to my anti-fraud team to examine Direct Deposit Fraud. I confess. I bullied agency executives, shared executive contact information, and circumvented the chain of command to connect DOGE with the people who get stuff done.⁹

And to make matters worse, a new report last Wednesday revealed that you "requested in a meeting on Tuesday that managers present [you] a plan for a 50 percent reduction in staff, a mass firing that could affect tens of thousands of employees across the country. This would have a significant impact on the program, almost certainly lead to limits on SSA services, such as the closure of field offices and increased wait times for seniors, people with disabilities, and others who need assistance with SSA benefits and information.

This is a deeply troubling set of facts, revealing that you may have acted against agency policy – or even illegally – to facilitate DOGE's efforts to access SSA systems, and that President Trump then rewarded you by naming you Acting Commissioner, and are now producing orders to lay off thousands of SSA employees that are responsible for providing SSA services and assistance to millions of Americans. To better understand the threat posed by DOGE to Americans who have entrusted SSA with their most sensitive information, I request that you answer the following questions:

- 1. What access to SSA systems does DOGE currently have?
 - a. Which DOGE-affiliated individuals have access to SSA data?
 - b. What personal data belonging to beneficiaries have these individuals accessed?
- 2. What role did you play in the decision to give DOGE-affiliated or others that access?
 - a. Please describe the nature and timing of any conversations between you and Trump transition or DOGE-affiliated individuals regarding access to SSA data and information.

- 3. What were the circumstances under which you were name Acting SSA Commissioner?
 - a. When did you learn of this appointment?
 - b. With whom in the Administration did you discuss this appointment?
 - c. What were the reasons for former Acting Commissioner Michelle King's departure from the agency?
 - d. Did you have any discussions with Trump Administration officials regarding Ms. King's departure prior to its announcement? If so, please describe the nature of these conversations.
- 4. Were you placed on administrative leave at the agency prior to your appointment as Acting Commissioner? If so, when and why were you placed on leave?
- 5. Were you the subject of any internal SSA investigation prior to being name Acting Commissioner?
 - a. If so, why were you investigated?
 - b. What is the status of this investigation?
 - c. If the investigation is not ongoing, what was its outcome, and when did end?
- 6. Did you request in a February meeting that SSA managers present you with a plan for a major reduction in SSA staff?
 - a. If so, why did you make this request?
 - b. Were you acting under direction or orders from President Trump or other Trump Administration officials?
 - c. If these cuts are enacted, how will you ensure that seniors, individuals with disabilities, and other SSA beneficiaries do not face reductions in services, increased wait times for services, or other limits to obtaining benefits from or information about the SSA program?

Thank you for your attention to this important matter. Given the urgent nature of this inquiry, I ask that you provide answers to my questions no later than March 10, 2025.

Acting Commissioner Dudek:

We are sending this letter to express our alarm over the coordinated attack on the Social Security Administration (SSA). The Department of Government Efficiency (DOGE), under the direction of unelected and non-Senate confirmed billionaire Elon Musk, has initiated a number of actions that will directly harm Americans receiving Social Security benefits despite President Trump's promise "not to touch" the program. The cuts taking place under this Administration reveal a reckless disregard for the lives of the 70.6 million Americans receiving benefits from SSA-administered programs.

While DOGE claims to be concerned with "waste, fraud, and abuse," the reality is that it is dismantling the SSA and preventing it from working for the American people. First, we understand that in response to pressure from DOGE, **SSA** has requested a plan for a 50 percent reduction in staff.³ This would affect tens of thousands of employees and millions of beneficiaries. It would also come at a time when the agency is already dangerously understaffed. Last year, SSA faced its lowest staffing level in 25 years despite needing to serve more Americans than ever before.⁴

Second, DOGE has initiated numerous Social Security office closures. These offices help the Agency provide benefits to millions of people across the country.⁵ The closures are proof that this Administration is not interested in improving the public's experience navigating government programs or in protecting Social Security. Instead, the Administration is interested in enriching billionaires to the detriment of everyday Americans.

DOGE is also working to gut SSA from the inside out, rendering the agency incapable of serving the public. One alarming example is the closure of the Office of Civil Rights and Equal

Opportunity (OCREO) at SSA—a closure consistent with the Administration's open hostility towards people with disabilities. OCREO ensures members of the public with disabilities have meaningful access to SSA's benefits, programs, and activities in accordance with Section 504 of the Rehabilitation Act of 1973 (Section 504).⁶ This office is a key enforcer of the right of disabled Americans to access SSA and its programs. Examples of those impacted include:

- Roughly 6.3 million blind or disabled recipients of federally administered Supplemental Security Income payments (SSI), including 1.0 million children;⁷ and
- More than 8.7 million disabled beneficiaries receiving Social Security Disability Insurance Program benefits, including disabled workers, disabled widow(er)s and disabled adult children.⁸

OCREO's closure will impact millions of disabled Americans. When people with disabilities who qualify for a program through SSA encounter barriers to accessing their benefits, there is now no one at SSA to turn to in seeking remedies. Furthermore, OCREO ensures that federal employees with disabilities are provided the reasonable accommodations they are guaranteed under law, which enable them to perform the essential functions of their job. To be clear—these are <u>statutorily required functions under the Rehabilitation Act</u>.

On February 26th, the Office of Management and Budget (OMB) and Office of Personnel Management (OPM) issued a memo with guidance on agency reductions in force and reorganization plans (ARRPs). This guidance explicitly states "agencies or components that provide direct services to citizens (such as Social Security, Medicare, and veterans' health care) shall not implement any proposed ARRPs until OMB and OPM certify that the plans will have a positive effect on the delivery of such services." We are deeply concerned that the actions by SSA thus far already are having a negative effect on thousands of employees and millions of beneficiaries.

In the last week, OCREO is one of several offices, including the Offices of Transformation and Analytics, Review, and Oversight, that the Administration is dismantling within SSA. By stripping SSA to its bones, the Administration is ensuring that SSA cannot administer programs and cannot serve beneficiaries resulting in negative effects in defiance of the OMB and OPM memo. This is an attack on the 70.6 million people who receive benefits through SSA—people who paid into Social Security their entire lives before retiring, injured workers being paid on disability, widows, children with disabilities, and more.¹¹

This coordinated attempt to take away benefits that the American people have earned and to which they are entitled must stop now.

For these reasons, we request that you respond to the following questions no later than March 14, 2025:

- 1. For the SSA at large, please state how many staff have left or been terminated from SSA since December 31, 2024. Within this number, please identify:
 - a) How many SSA employees took the deferred resignation offered through the "Fork in the Road" email dated January 28, 2025;
 - b) How many employees were fired due to their probationary status;
 - c) How many employees were placed on administrative leave, pending termination and:
 - d) How many employees you anticipate firing due to the most recent OMB memo dated February 26, 2025.
- 2. Please provide the number of civil rights investigators at OCREO placed on paid administrative leave, fired, or otherwise displaced and their average caseload.
- 3. For each office that SSA has dissolved since January 20, 2025, please provide the number of staff placed on paid administrative leave, fired, or otherwise displaced.
- 4. Given the reductions in staff described in Questions 1-3, please advise how you will meet the needs of beneficiaries as SSA has record high caseloads.
- 5. Please provide a detailed plan for how SSA will comply with the statutory requirements of applicable federal civil rights laws, including but not limited to Section 504 and 29 CFR Part 1614.
- 6. To the extent the responses to Questions 4 and 5 include the use of technology, please answer the following:
 - a) Which specific technologies will be utilized?
 - b) Are or will the technologies be funded via Congressional appropriations?
 - c) What entities will supply these technologies?
 - d) Are any technologies currently under development or in planned development, and if so, who is developing them?
 - e) Will beneficiaries be asked to interface with said technologies instead of speaking with SSA employees?
- 7. Per 29 CFR Part 1614, SSA is to designate a Director of Equal Employment Opportunity (EEO Director), EEO Officer(s), and such Special Emphasis Program Managers (e.g., People With Disabilities Program, Federal Women's Program and Hispanic Employment Program), clerical and administrative support as may be necessary to carry out the functions of such regulations. Please provide SSA's staffing plans and designations to comply with 29 CFR 1614.
- 8. Per 29 CFR Part 1614, including 29 CFR 1614.203, what is the office designated by the agency to oversee the reasonable accommodation process, agency employee connected with

the application process, or any other individual designated by the agency to accept such requests?

9. Given the extensive cuts and significant programmatic changes already underway at SSA, how will the agency fulfill the President's promise that beneficiaries will not be impacted by DOGE cuts?

Acting Commissioner Dudek:

We write to express our strong concern over the Social Security Administration's (SSA) reckless actions to shutter offices, slash SSA's workforce, and close field offices across the country. These draconian cuts to SSA will have a devastating toll on Americans' ability to access their earned benefits. Additionally, they seem to have been made with no consideration for their impact on the agency's ability to achieve its mission.

Nearly every American interacts with SSA at certain points in our lives, particularly during significant moments like a birth and adoption; marriage and divorce; onset of a life-altering disability; retirement from work; or the death of a spouse. SSA employees help seniors enroll into Medicare, help Americans determine when to retire and file for Social Security benefits, and help Americans file for disability benefits. Access to in-person services is especially important for people who have difficulty speaking by phone, who do not have reliable internet access, and people who have difficulty understanding program rules. Every day, over 120,000 people visit and 233,000 call SSA's field offices, on average. In Fiscal Year 2024 alone, SSA processed over 8 million Social Security benefit claims, 1.4 million Supplemental Security Income (SSI) claims, and received over 57 million calls to their field offices and nearly 80 million calls through SSA's 1-800 Number.

As one of the nation's most popular and effective programs, Social Security provides a foundation of income on which workers can build for their retirement, as well as valuable insurance protection against unexpected hardship. By slashing staff and eliminating field offices, fewer Americans will be able to seek assistance during pivotal life events and risk causing further hardship to those in dire circumstances.

The agency's brash decision defies the President's pledge to not touch Social Security and the Administration's policies. In the Office on Management and Budget and Office of Personnel Management joint memo about slashing the federal workforce, there are references to ensuring that any workforce reductions at Social Security will have a positive effect on the delivery of services.² Based on the rash actions to date, we have serious concerns that the administration

takes this assurance and commitment seriously. Empirical evidence and basic common sense shows that further reducing staff and field offices will have a substantial adverse impact on Americans' ability to access Social Security benefits. A 2017 academic study found field office closures lead to "large and persistent reductions" in the number of applications and receipt of disability benefits, which are more acutely felt among those with severe physical and mental disabilities, low income, and those without a college degree. Similarly, a 2020 Social Security Advisory Board report found that a two-year long hiring freeze and reduction in field office operating hours resulted in higher congestion in the field offices, with the number of visitors waiting over an hour increased by 78 percent and the average wait time increased 37 percent to 24.9 minutes. Simply put, making it more cumbersome to access Social Security does not make the program more efficient nor does it improve customer service. The administration hasn't even provided estimates of what the changes it has already taken credit for will mean for customer services and key workloads.

Your characterization of its recent reorganizations and staffing reductions as "duplicative," "redundant" or "non-mission critical" is an utter farce and insulting to the thousands of Americans who dedicated their career in service of the agency's mission. These public servants worked on critical projects focusing on improving customer service for all its customers, reducing waste, fraud, and abuse, and ensuring that all Americans, particularly those with disabilities, can access SSA offices and their earned benefits. Moreover, eliminating those staff does not eliminate their work. Driving staff out of the agency and forcing the remaining staff to complete more work is a recipe for burnout, low morale, and worse productivity.

Despite your stated commitment to transparency, the agency's decision to strip down SSA while keeping Members of Congress, community leaders, advocates, and the public in the dark undermine the agency's own stated policy and best practices. As you know, even subtle changes to SSA's service delivery can cause significant disruptions to its customers. SSA must take care to ensure that community leaders and stakeholders are consulted so service to the public continues in the most effective, efficient, and caring way possible. The only explanation that can justify SSA's actions is to appease the President and Elon Musk in their crusade to dismantle the federal government. Musk made his views towards Social Security clear when he called the program "the biggest Ponzi scheme of all time."

We urge you to cease any activities that threaten Americans' Social Security benefits. To understand the agency's recent actions, please detail the steps SSA took to ensure customer service remains uninterrupted for the millions of Americans no later than March 12, 2025. This should include:

- 1. Any and all qualitative and quantitative analyses conducted to evaluate the impact of these changes on SSA's ability to administer the programs and on SSA's customers since January 20, 2025;
- 2. A report detailing how:
 - a. Reduced staff in the regional offices would improve customer service;
 - b. Reduced staff in field offices would improve customer service;
 - c. Reduced staff in state disability determination services would improve customer service;
 - d. Reduced staff in hearings offices would improve customer service;
 - e. Reduced staff in appeals councils would improve customer service;
 - f. Reduced staff in Social Security Card Centers would improve customer service;
 - g. Reduced staff in teleservice centers would improve customer service;
 - h. Reduced staff in program centers would improve customer service;
- 3. A report explaining how driving out experienced SSA employees with at least 20 years of experience would improve customer service;

For the decision to consolidate ten regional offices into four, please also provide:

- 1. The number of SSA employees working when the regional office closed and their responsibilities;
- 2. The percentage of SSA employees in the regional office who were terminated, resigned, or retired;
- 3. The number of claims or post-entitlement actions that were pending in the regional office at the time of closure, and how SSA will ensure those pending cases are timely addressed;
- 4. The list of evaluating factors or criteria SSA considered in determining to close the regional office.
- 5. A list of all community outreach meetings SSA conducted with key community leaders (e.g., mayor, city council, etc.), unique institutions (e.g., schools for the blind, hospitals, prisons, etc.), advocacy groups, community-based organizations that represent SSA clients, employees and labor groups about the proposed closure, consolidation, or relocation of the affected office since January 20, 2025;
- 6. Whether you or other senior SSA officials conducted any outreach with Members of Congress and U.S. Senators and/or their staff who represent the affected regional office about the proposed closure prior to your February 28 announcement.

Dear Mr. Bisignano:

We write regarding our concerns about the impact of the Trump Administration's efforts to fire thousands of workers that Americans rely on to process and disburse their Social Security checks. President Trump promised that his administration "won't touch" Americans' hard-earned Social Security benefits, but now Elon Musk and the Department of Government Efficiency (DOGE) are planning regional office closures and mass layoffs at Social Security Administration (SSA) facilities. The Acting SSA Administrator has admitted that DOGE could "break things," raising concerns about an interruption of benefits and threatening the finances of millions of Americans. As President Trump's nominee for SSA Commissioner, you will be responsible if the Trump Administration's attacks on the program result in failures or delays in getting Americans their Social Security checks – in other words, a backdoor cut to benefits.

Last week, SSA announced plans to cut over 7,000 employees and close regional offices. This would represent a reduction in workforce of over 10 percent and will have devastating impacts on the program: Social Security offices nationwide receive about 170,000 in-person visits and 250,000 calls each day from Americans who need help with their benefits. This includes seniors who rely on their Social Security check – money they earned through a lifetime of hard work – and millions of disabled individuals and their parents who receive Social Security disability payments. These cuts will hurt all Americans that receive Social Security checks. Indeed, they

already have: SSA workers have reported that the wait times for basic services have dramatically increased, sometimes by hours.⁷

And these announced cuts appear to be just the beginning. Public reports indicate that SSA may further reduce its workforce to just 50 percent of its current size. If allowed to continue, the results will be devastating. In the 1980s, substantially smaller cuts to the Social Security workforce resulted in 80,000 eligible Americans failing to receive their benefits. These new cuts could result in millions of Americans being cheated out of the money they earned throughout their careers, while limiting SSA's ability to catch and correct payment errors. The net result could be a disaster: more overpayments and waste in the system, at the same time that Americans who have earned their Social Security benefits are unable to receive them.

We have already asked Acting Commissioner Dudek to explain how the SSA will continue to provide services in light of these cuts. Mr. Dudek – who himself was appointed for his willingness to cooperate with DOGE's efforts to dismantle SSA – has admitted that the system is under threat. He has reportedly informed staff that DOGE "outsiders who are unfamiliar with nuances of SSA programs" are currently making all the decisions – and confirmed the fears that "they will make mistakes." But he has refused to answer our questions. Meanwhile, President Trump and Elon Musk – who calls Social Security a "Ponzi scheme" – continue the efforts to dismantle the program.

You are the nominee to be the next SSA Commissioner, and if confirmed, will have to implement and face the consequences of these extraordinary cuts to Social Security program staff. To better understand how you would address the threats from these cuts, we request that you provide answers to the following questions by March 20, 2025:

- 1. If confirmed, will you take direction from Mr. Musk or DOGE officials?
 - a. Will you deny Mr. Musk or other DOGE officials access to sensitive Social Security Administration payments systems?
 - b. Will you deny Mr. Musk and other DOGE employees access to individuals' sensitive personal health and financial information?
 - c. Will you continue to implement DOGE's directive to reduce the workforce by 50 percent?
 - d. Would you implement a DOGE directive to stop sending benefits to any individuals or group of individuals?

- 2. Mr. Musk has called Social Security a "Ponzi scheme." Do you agree with this assessment?
- 3. If confirmed, how will you address the disruptions to SSA customer service and long wait times that layoffs have already caused?
- 4. If confirmed, do you plan to continue layoffs or reductions in force at SSA?
 - a. If so, please describe your plans.
 - b. If so, please describe how you will ensure that reductions in workforce don't result in missed payments and increased wait times?
- 5. If confirmed, will you close SSA field offices?
 - a. How will you determine which offices to close?
- 6. Before closing any Social Security field offices, will you commit to conducting the below analysis?
 - a. Determining how long it currently takes to reach a customer service representative at the office, both by phone and in person.
 - b. Determining the office's average wait time for new applicants and for adjudication of appeals.
 - c. Identifying the next closest office.
 - d. Conferring with the representative of the district in which the office is located.

Dear Mr. Bisignano:

We write regarding our concerns about the Trump Administration's ongoing efforts—in conjunction with Elon Musk's Department of Government Efficiency's (DOGE)—to hollow out the Social Security Administration (SSA) and deprive Americans of Social Security benefits they earned and need. In recent days, SSA officials have intensified their efforts to undermine the program, imposing burdensome administrative requirements on beneficiaries while simultaneously cutting thousands of agency jobs and closing dozens of Social Security offices." At the same time, there have been reports that Musk's Wall Street allies have quietly infiltrated the SSA.²

These new developments leave us deeply concerned that DOGE and the Trump Administration are setting up the SSA for failure—a failure that could cut off Social Security benefits for millions of Americans—and that will then be used to justify a "private sector fix." Republicans have flirted with the idea of privatizing Social Security for over two decades.³ The latest changes at the Social Security Administration leave us worried that Elon Musk—with his clear disdain for the program that provides financial security to millions of Americans⁴—has taken up the mantle as the latest privatization crusader.

On March 11, 2025, we wrote to you about how layoffs and office closures are impacting the SSA's services. We have since learned that the SSA is changing its policies to require

beneficiaries who are not able to verify their identity online to do so in person. This new policy—in conjunction with fewer offices and reduced staffing—could be disastrous. It will force some seniors or disabled individuals to travel over 100 miles to sign up for benefits, creating particular problems for vulnerable populations, including individuals with severe disabilities or illnesses. An internal memo from SSA officials acknowledged that the policy could lead to "service disruptions."

There is no need or rationale for these threats to Social Security benefits.

These changes are especially concerning in light of recent personnel changes at the SSA. Mr. Musk has planted a number of his private equity friends in various parts of the agency. Their exact roles at the agency remain unclear, but we know that private equity's typical playbook is to pillage organizations, extracting anything of value before selling the remains for parts. We are deeply concerned that these individuals will be advising you on how to "improve" the SSA. Their influence is especially worrying considering that a number of them, including Musk's long-time ally Antonio Gracias, appear to remain employed by their financial firms. ¹⁰

And it is not just Musk-aligned private equity firms that could potentially benefit. Already, financial services firms are salivating at the possibility of profiting off of Americans' hard-earned retirement benefits. 11 Even your own payment firm, Fiserv— which "enables money movement for thousands of financial institutions and millions of people" 2 — could theoretically benefit from a privatization of Social Security.

We are gravely concerned about the current trajectory of the SSA and more specifically, that those charged with leading it might profit off its destruction. As we have noted, DOGE's efforts may be a "prelude to privatization." ¹³

You are the nominee to be the next SSA Commissioner, and if confirmed, will have to address the consequences of DOGE's recent actions. To better understand how you would address our concerns, we request that you provide answers to the following questions before the Committee votes on your nomination:

- 1. Will you commit to not privatizing any components of the Social Security program?
- 2. Will you commit not to closing any Social Security offices if these closures cause severe disruptions, dramatically increased travel times, or disproportionately impact individuals with severe disabilities or illnesses?
- 3. Will you commit to reversing any layoffs that cause increased wait times or otherwise threaten SSA beneficiaries' ability to collect their benefits?
- 4. Will you commit to not implementing any new rules—or to immediately reverse any rules created by the Trump Administration prior to your confirmation—that create additional hurdles for Social Security beneficiaries?
 - a. Will you reverse the rule requiring phone-applicants to verify their identity in person?
- 5. If confirmed, will you:
 - a. Remove the Musk-allied individuals with ties to private equity firms or other firms that could benefit from the erosion of SSA's ability to provide basic services?
 - b. Require that any individuals employed by or advising the SSA divest any individual stocks or other holdings in entities that could profit from the privatizing of SSA functions?
- 6. Do you retain any equities in Fisery?
 - a. If no, do you commit to divesting from any holdings in Fisery?

Dear Acting Commissioner Dudek:

We write with concern regarding reports we began receiving earlier this week about disruption in Social Security benefits for Supplemental Security Income (SSI) recipients. These beneficiaries are some of the most vulnerable in the nation—low-income seniors and children and adults with disabilities—and face extraordinary hardship if their benefits are delayed or disrupted. The reports come as the Trump Administration and Elon Musk's DOGE have invaded the Social Security Administration (SSA), improperly accessed SSA data, announced closures of Social Security offices, implemented policies making it more difficult for citizens to claim their benefits or address problems with them, and threatened further cuts to SSA. It would be outrageous if the Trump Administration, either due to incompetence or nefarious planning, is already disrupting, or threatening to disrupt, Social Security payments for the most vulnerable citizens in the country.

Our constituents have provided multiple disturbing reports of problems with their own SSI accounts or accounts that they manage for a disabled family member. They informed our offices that, after signing into their account on the Social Security Administration (SSA)'s website, where they normally see their monthly benefit amount and other information about their benefits, they instead found messages stating that they or their loved ones are "currently not receiving payments." The payment history and all data about benefits related to these accounts had also disappeared. Some of these constituents have informed us that the issue was quickly resolved and that their profiles now accurately reflect that they are recipients, but it is unclear if these problems have been fully resolved.

This alarming episode raises fresh questions about operations at SSA and the effects of the Department of Government Efficiency (DOGE)'s attacks on the agency, which you have helped facilitate.³ They are just the latest in a slew of concerning developments at the SSA—including

increased wait times and website crashes⁴—that have resulted from DOGE's efforts to hollow out the SSA by slashing the workforce and closing offices across the country. Indeed, we are concerned that these efforts are a precursor to attempts to make further cuts to Social Security, or privatize it entirely.⁵

SSI supports the most vulnerable Americans by providing monthly payments to children and adults with disabilities as well as seniors with very little income or resources. SSI recipients experience economic precarity at high rates, and even brief disruptions to benefits could have devastating impacts for these beneficiaries. Forty percent of SSI recipients still have incomes below the poverty line, even including their SSI benefits. SSI imposes strict income and asset restrictions on beneficiaries, meaning that people receiving SSI cannot have more than \$2,000 in their bank account (or \$3,000 for a couple) at a time. This means that if benefits are disrupted, beneficiaries have extremely limited resources to fall back on.

These recent reports of disruption—or threats of disruption—of Social Security benefits is deeply troubling. To understand the source of these problems, whether they have been resolved, and the implications for the future of Social Security, we ask that you please respond to the following questions by April 12, 2025:

- 1. Beginning on March 31, 2025, how many SSI beneficiaries received notices on their mySSA account indicating that they were "currently not receiving benefits"?
- 2. What was the cause of this misinformation appearing on their accounts?
- 3. How long did this misinformation appear on their accounts before the problem was resolved?
- 4. How many individuals experienced disruptions in benefits, such as delays or denials of benefits?
- 5. What was the cause of these disruptions?
- 6. How long did delays or denials of payments last before they were resolved by SSA?
- 7. Have you confirmed that all impacted beneficiaries' payments have been restored?
- 8. Has SSA provided any clarification or communication to affected beneficiaries on the misinformation? If so, please provide copies of such notices.
- 9. Was this disruption related to actions taken by DOGE or actors affiliated with DOGE?
 - a. Was this disruption caused by layoffs among staff administering SSI or administering SSA's online portal?

Dear Acting Commissioner Dudek:

We write to denounce the incessant havoc sparked by the Trump Administration's continual cuts to the Social Security Administration (SSA). Changes implemented by SSA leadership and the so-called "Department of Government Efficiency" (DOGE) include heinous staffing cuts, plans for indiscriminate closures of field offices around the nation, and limits to phone services. It is difficult to see how DOGE's attacks on the SSA, and the complicity shown by SSA leadership, will improve efficiency when we are already hearing stories upon stories of how SSA's changes have damaged the system responsible for ensuring timely, accurate payments—upending the lives of older adults and people with disabilities who rely on Social Security benefits that they **earned** to pay their rent, groceries, and medical bills.

Social Security lifts 22 million Americans, including 16 million older adults, out of poverty.² Many older adults rely on Social Security for life-saving sustenance—to ensure they have food to eat, a roof over their heads, and money to pay for medications. In fact, 40 percent of older Americans rely on Social Security as their only source of retirement income.³ Over seven million veterans received a Social Security benefit in 2024,⁴ while SSDI and Supplemental Security Income serve millions of workers with disabilities and their children.⁵ DOGE's attacks on the SSA will break down access to services, affect timely and accurate payment of benefits,⁶ and have disastrous consequences for Americans everywhere.

It is precisely because older adults, people with disabilities, and other deserving Americans count on Social Security that we are deeply concerned with efforts by DOGE and SSA leadership to impede access to SSA services. SSA has announced plans to slash at least 12 percent of its workforce, and offered a buyout incentives to staff, at a time when SSA staffing is at a 50-year low. SSA has also announced plans to close six of its ten regional offices, which coordinate and support the efforts of SSA employees. DOGE, meanwhile, has placed dozens of SSA offices

across the country on the chopping block. At the same time, SSA has decided to limit the services it makes available over-the-phone, after backing down from broader restrictions following an outcry by older adults and people with disabilities. SSA's new limits on over-the-phone services are still unacceptable, and the process used by SSA—swift revisions after public outcry—suggest the agency is *not* talking to the Americans who rely on Social Security the most *before* it makes its decisions. Instead, it appears that SSA leadership is pushing out half-baked ideas that lead to public confusion and panic.

SSA leadership should strive to serve the public, *not* Elon Musk and his cronies with the DOGE. We are already witnessing the consequences of SSA's complicity in DOGE's irresponsible actions and cruel intentions. Scammers have taken advantage of the confusion surrounding SSA changes to defraud older adults. The SSA website crashed 4 times in 10 days because servers were overloaded; phone wait time and foot traffic to field offices have skyrocketed. This chaos does not create "efficiency." It harms older adults and people with disabilities while undermining a program that is *already* efficient: Even as Social Security uplifts millions of older adults and people with disabilities, less than one percent of Social Security payments are improper—a percentage that includes underpayments as well as overpayments.

We are pleased that Elon Musk, the world's richest man, is skilled with technology, lives his life with unfettered access to services, and has not experienced what it is like to live with a severe disability or financial hardship. We are also pleased that the Trump Administration's supposed "leadership" is comfortable enough to believe older adults will not mind a missed Social Security payment. However, their experiences do *not* reflect the experiences of millions of Americans who rely on Social Security. The changes undertaken by SSA leadership and the DOGE disregard the reality of daily life for those millions of Americans. They are spearheaded by the out-of-touch, unelected leadership of the DOGE. They hurt our nation's older adults and people with disabilities—our grandparents, our friends, and our neighbors. And they risk debilitating the Social Security System and denying Americans the money they are owed.

In light of our concerns, we ask that you answer the following questions:

1. Reports indicate that an internal memo proposing changes to the Social Security claims process was circulated within SSA on March 13, 2025.¹⁵ The memo also reportedly details how the changes could significantly impact the ability of Social Security recipients to access their benefits, including through "longer wait times and processing time" and "increased challenges for vulnerable populations." Please provide:

- a. An unreducted copy of the March 13, 2025 memo, which was sent from Acting Deputy Commissioner Doris Diaz to Acting Commissioner Leland Dudek;
- Copies of any other written communications that are related to the March 13, 2025 memo, including e-mail, texts, letters, memorandums, or other documents;
 and
- c. Copies of any written communications, including e-mail, texts, letters, memorandums, or other documents, related to SSA's decision to revise its changes to phone services, as announced on March 26, 2025.¹⁷
- 2. SSA's new limitations on over-the-phone services are likely to increase the number of visitors per-week to SSA field offices, a potential impact reportedly detailed by SSA leadership in its March 13, 2025 memo.¹⁸ The DOGE website lists numerous SSA offices throughout the United States that will have their lease terminated,¹⁹ and one analysis suggests that 47 SSA offices are slated for closure.²⁰

Please answer the following questions about potential SSA field office closures:

- a. SSA claims in a press release on March 27th that the SSA "has not permanently closed or announced permanent closure of any local field office." Public reporting shows that multiple SSA field offices across the country were publicly slated for lease termination, many of which were taken off DOGE's website prior to the press release.²²
 - i. Explain the reason for the removal of the field offices previously listed for lease termination on the DOGE website.
 - Explain why the SSA did not issue a public correction of the information provided on SSA lease termination after its removal off the DOGE website.
- b. Provide detailed information on each location on the DOGE and GSA lease termination lists that include an SSA office, including any locations that include an SSA field office but are leased by other federal departments, such as the General Services Administration. Please include the following information for each location:
 - i. What SSA functions operate out of the location, whether the location is open to the public, what services the location provides to the public, and how many members of the public visit the location each day.
 - ii. How the SSA office will be impacted by the lease termination listed on the DOGE website, including which services at the SSA office will cease to be offered to the public and whether the SSA office will be closed entirely.

- c. Which field offices is SSA planning to close, or considering for closure, through December 31, 2026, regardless of whether the location appears on the DOGE lease termination list? Please provide a detailed list that includes the name, city, and state of each field office.
- d. How will SSA analyze the impact of potential field office closures on people who use SSA services in light of SSA's new limitations on over-the-phone services? If SSA does not plan to include the new limitations on over-the-phone services when analyzing potential field office closures, please explain why.
- 3. SSA's new limitations on over-the-phone services are likely to drive more people to use the SSA website, including "my Social Security" accounts, when filing for benefits or making changes to their payments. Past oversight conducted by the Senate Aging Committee demonstrated that federal departments and agencies often fail to make their websites fully accessible for people with disabilities, as required by law.²³ Further, the unelected billionaire running DOGE demonstrated his callous disregard for people with disabilities when he decimated Twitter's accessibility team after taking over the company.²⁴
 - a. How many staff held a role in ensuring SSA website accessibility for people with disabilities on January 20, 2025?
 - b. How many staff held a role in ensuring SSA website accessibility for people with disabilities on April 8, 2025?
 - c. How many staff with a role in ensuring SSA website accessibility for people with disabilities were fired or accepted a buyout between January 20, 2025 and April 8, 2025?
 - d. How many contracts related to ensuring SSA website accessibility for people with disabilities have been delayed or cancelled since January 20, 2025? Please describe each delayed or cancelled contract and provide a justification for each delay or cancellation.
 - e. How many tests to evaluate SSA websites for accessibility for people with disabilities have been delayed or cancelled since January 20, 2025? Please provide a justification for each delayed or cancelled accessibility test.
- 4. Please describe how SSA consulted with older adults and people with disabilities before making the initial decision, announced on March 18, 2025, to implement new limits to over-the-phone services.²⁵ Please include the names of groups representing older adults and people with disabilities that were contacted for feedback. If SSA did not conduct this outreach, please explain why.

If SSA does not plan to collect feedback from older adults and people with disabilities in this fashion, please explain why.

Acting Commissioner Dudek:

We write to express our strong outrage and deep concern over the Social Security Administration's (SSA) recent actions to slash the agency's workforce and reported decision¹ to make even more severe layoffs in the coming days and weeks. Your reckless actions have already inflicted a devastating toll on Oregonians and Americans' access to their Social Security and Supplemental Security Income benefits.

According to agency data, staff in the Warrenton and La Grande field offices in Oregon declined by at least twenty-five percent as a result of your disastrous decisions to reduce the agency's workforce, and the field office in The Dalles also saw a substantial drop in workers. These three rural field offices already faced staffing shortages before these cuts, with just twenty combined employees serving more than 232,000 Oregonians in ten counties and parts of Washington and Idaho.

As you know, nearly every American interacts with SSA at the pivotal moments of their lives. Access to in-person services is especially important for each of those moments, especially for people who have difficulty speaking by phone, who lack reliable internet access, and who have difficulty understanding program rules. Any disruption in service, especially interruption of benefit payments, can be financially devastating for families. For many of these Oregonians, field offices are often their only channel of service. These field offices are located in predominantly rural areas, with the nearest field office more than 50 miles away from many users. Additionally, more than 400,000 Oregonians lack internet access at home because the state's size and rugged terrain make it costly and difficult to build broadband infrastructure. Without in-person services, if those Oregonians have difficulty using a phone they are 100 percent cut off from their benefits.

At a time when field offices across the country are feeling these staffing cuts, promises of 'technology', remote workload sharing, and staff relocations to affected field offices do little to address the overarching staffing demand given the case volume. Simply put, your decisions jeopardize Oregonians' access to their Social Security benefits without providing any substantive plans to provide quality service to these communities.

We write with alarm regarding ongoing issues with the Social Security Administration (SSA)'s website and the Department of Government Efficiency (DOGE)'s plans to worsen this situation by firing up to 50 percent of employees in the Office of the Chief Information Officer (OCIO)—the department responsible for protecting Americans' most sensitive information, maintaining the agency's benefit claims processing systems, and managing the SSA's website and the online portal benefits recipients rely on. We are concerned these cuts will lead to further website and benefit disruptions, preventing tens of millions of Americans from accessing their hard-earned Social Security and Supplemental Security Income benefits.

Under your watch, SSA has initiated a series of severe staffing cuts to critical departments, impeding beneficiaries' ability to seek customer service and access their account information. On February 28, 2025, you announced plans to reduce SSA's workforce by over 12 percent.² Seventy-eight percent of SSA employees who have already been fired worked in field offices directly serving SSA recipients.³ Of the remaining employees SSA is expected to cut, hundreds will come from OCIO—which has been directed to reduce its staff by 50 percent.⁴ Given ongoing issues with SSA's websites and online portals, these cuts are particularly troubling because OCIO oversees SSA's internal computer systems, including the operation of SSA.gov.⁵

The cuts to OCIO are intentional—and dangerous. On March 27, President Trump signed an executive order that ends collective bargaining rights for many federal workers, making it easier

to fire them or shift their duties.⁶ The order takes aim at unions who have "declared war on President Trump's agenda," like the American Federation of Government Employees (AFGE), which represents OCIO staff. The Administration's move to strip these employees of their bargaining rights is making it easier for DOGE to fire OCIO staff and replace them with employees who are "more amenable to doing what [DOGE] want[s] to do." But these actions are dangerous for SSA—OCIO employees are the ones who know SSA's programming language and can "keep[] the technology operating and addressing things that go wrong." This technology includes the administration and oversight of the agency's anti-fraud software, which DOGE has been tampering with. This would not be the first time DOGE has cut an agency at its knees, leaving customers scrambling, and then re-hiring fired employees. In March, DOGE re-hired 50 fired technology Department of Education employees who had critical institutional knowledge. Cutting OCIO in half runs the risk of repeating DOGE's previous mistakes.

Since you took over SSA, the agency has failed to maintain its online infrastructure. While you have been directing SSA beneficiaries to file for benefits online, SSA.gov has "crashed repeatedly...with outages lasting anywhere from 20 minutes to almost a day." Last week, we wrote a letter to you asking for details as to why our constituents faced a variety of account issues during one of these outages on March 31st, including receiving messages that they were "not receiving payments" and the disappearance of their account histories, but you have yet to respond. It is unsurprising that weeks after you allowed DOGE to invade SSA, improperly access SSA data, and announce closures of Social Security offices, our constituents began having problems accessing their benefits. In addition, SSA field offices are facing more frequent technology glitches, preventing workers from providing customer service to beneficiaries who need help. We are concerned that these recurring issues will impact the benefits of our constituents—many of whom rely on Social Security to pay rent or put food on the table.

These disastrous cuts also expose SSA to systems vulnerabilities and risk Americans' data to hackers and foreign agents seeking to obtain Americans' private information. In addition to the

dozens of senior SSA officials with centuries' worth of experience who have resigned or retired, SSA's entire cybersecurity leadership was also part of the exodus.¹⁵ Leaving Americans' most sensitive information unguarded places immeasurable financial and economic harm on our most vulnerable.

Before your announced cuts, SSA was already "at a 50-year staffing low" while "serving the highest number of beneficiaries...in the history of the agency." The Trump Administration's cuts will put further strain on SSA, making it more difficult for this agency to deliver well-deserved benefits to hard-working Americans. We ask that you immediately cease all OCIO firings and act swiftly to restore SSA system and website functionality to prevent any further disruption of Social Security beneficiaries' access to their account information and benefits. In addition to answering the questions in our April 7, 2025 letter, we request that you provide the following information by April 27, 2025:

- 1. How many employees from OCIO have left SSA since January 20, 2025, either voluntarily or involuntarily?
- 2. How many additional employees from OCIO are you planning to fire?
- 3. What analysis led you to cut 50 percent of OCIO staff? Please provide that analysis.
- 4. Why was OCIO in a different bargaining unit than other SSA employees?
- 5. SSA's beneficiary portal, "my Social Security," was down for several hours last week. 17 How do you plan to maintain SSA's beneficiary-facing portal when the division tasked with overseeing the portal is being cut in half?
- 6. How will firing, reassigning, or pressuring half of the OCIO employees to retire or resign help improve the internal and external technology issues that SSA has faced since DOGE's invasion of the agency?
- 7. Do you plan to hire federal contractors to perform OCIO's functions? If so, which functions?
- 8. What role is DOGE playing in terminations across SSA?
- 9. What role is DOGE playing in terminations, reassignments, or separation incentives in OCIO?

Acting Inspector General Anderson:

We are writing to express deep concern regarding recent developments at the Social Security Administration (SSA) that will drastically disrupt—if not reduce—Americans' earned benefits. In just the last month, SSA has rapidly shuttered offices, slashed thousands of its employees, and abruptly changed (and then reversed) long-standing customer service practices, with little transparency or consideration on its impact to its customers. In the past two months, SSA has dramatically restructured the agency and slashed its workforce, including:

- 1. Announcing plans to dramatically reduce staff by at least 7,000, from 57,000 employees to 50,000, with additional layoffs reportedly under consideration;
- 2. Executing mass layoffs to "non-mission critical" positions in retirement and policy, research, customer service, human resources, IT support, and civil rights;
- 3. Pressuring employees to resign, retire, or reassign to a front-line position;
- 4. Eliminating over half of the agency's regional offices, which provide technical assistance to field offices and liaise with state and local community organizations who support individuals file for Social Security benefits;
- 5. Reducing staff in the agency's congressional and casework liaison office to three employees; and
- 6. Dissolving other offices essential in proper administration of the Social Security programs.

These actions have already created a chilling effect among the agency's workforce, with several senior SSA officials with centuries' worth of institutional knowledge and experience having already left the agency. We are concerned that this hostile environment will foster burnout, low morale, higher attrition, and worse productivity among employees. Collectively, this will undoubtedly lead to disruption in benefit payments and increasing barriers for Americans to access their Social Security benefits.

We request SSA OIG review the agency's actions to drastically reorganize its organizational structure, close numerous offices, and significantly reduce its workforce to determine whether it has affected the agency's ability to provide quality customer service. Specifically, we ask the office to review:

1. Whether SSA conducted any qualitative or quantitative analyses to evaluate the impact of these changes on SSA's ability to administer the programs and on SSA's beneficiaries

- since January 20, 2025, which may include Service Delivery Assessments (SDAs) or Service Area Reviews (SARs);
- 2. Whether reducing regional offices from ten to four and reducing regional office staff contributed to improved customer service;
- 3. Whether incentivizing field office employees to retire or resign improved customer service in the field offices;
- 4. Whether incentivizing hearing office employees to retire or resign improved the agency's ability to timely process disability appeals hearings;
- 5. Whether incentivizing appeals council employees to retire or resign improved the agency's ability to timely process appeals council decisions;
- 6. Whether incentivizing staff in Social Security Card Centers to retire or resign improved customer service in Social Security Card Centers;
- 7. Whether incentivizing teleservice center employees to retire or resign improved the agency's ability to provide timely assistance to beneficiaries using the 1-800 service; and
- 8. Whether incentivizing staff in program centers to retire or resign improved the agency's ability to timely process clearances.

We further ask that your office provide us quarterly updates of the impact of the agency reorganization and any future workforce reductions has had on customer service.

Ms. Anderson:

We are writing to express deep concern regarding actions at the Social Security Administration (SSA) which undermine Americans' privacy rights.

Specifically, we are concerned that SSA has granted the "Department of Government Efficiency" (DOGE) unfettered access to the agency's most sensitive data. We are also concerned that, in the weeks before his surprise appointment as Acting Commissioner of Social Security, Leland Dudek improperly disclosed information including personally identifiable, protected health information, federal tax information, or other sensitive personal and financial information in SSA data systems, potentially violating federal privacy laws.

SSA administers the three largest federal-benefit programs, the Old-Age Survivors Insurance, Disability Insurance, and Supplemental Security Income (SSI) program. Collectively, SSA pays over \$1.3 trillion in monthly benefits to over 70 million Americans each year. SSA also provides support to administer other federal programs and laws, including Medicare, Medicaid, SNAP, eVerify, Children's Health Insurance Program (CHIP), and the Help America Vote Act, and verifies SSNs to federal and state agencies and employers.

Federal laws protect sensitive personal and financial information from improper disclosure and misuse, including by barring disclosure to individuals who lack a lawful and legitimate need for it. Maybe nowhere is that more important than at SSA. For example, the Privacy Act of 1974, as amended (5 U.S.C. 552a, Public Law 93-579); the Federal Information Security Management Act (FISMA) (44 U.S.C. § 3541); and Section 1106 of the Social Security Act (42 U.S.C. § 1306) all protect Americans against the unwarranted and unlawful disclosure, destruction, and transport of their personal information stored by SSA. Moreover, SSA applies "more strict confidentiality standards than those found in the Privacy Act" to program records because they include information about a much greater number of people than its administrative records; the information collected for program purposes is often very sensitive; and claimants are required by statute and regulation to provide SSA with this information in order to establish the requirements for benefits.

We are therefore extremely concerned about individuals associated with the DOGE accessing SSA data without legitimate reasons as it may be used for improper uses, which could include adjusting, delaying, or withholding benefit payments.

In response to Senator Wyden's February 19, 2025 letter requesting information about DOGE's activities at SSA, Dudek confirmed he disclosed to DOGE personnel sensitive personal and financial information held by SSA, such as personally identifiable information, protected health information, and federal tax information.² Further, Mr. Dudek also confirmed that he had indeed granted read-only access to special government employees -- operating under the guise of DOGE's direction -- to SSA systems despite being fully aware that these "master records and payment files contain" personally identifiable information and federal tax information. While Dudek contends that read-only access is acceptable because it does not allow an individual to edit or delete certain information, read-only access does permit these individuals to copy and paste, export, and screenshot SSA data systems or otherwise compile it for analysis.³ As he notes in his February 25 response to Senator Wyden's letter, Dudek provided this unfettered access to data with full knowledge that none of these individuals had a completed FBI background check, and one of them had not completed a Standard Form 86 (Questionnaire for National Security Positions). As such, it is not clear from his written responses on whether they even have appropriate security clearances to any access to SSA's data.

It is the essential mission of the SSA Office of Inspector General to conduct oversight of SSA, to correct programmatic vulnerabilities, to ensure laws are appropriately followed, and to hold bad actors accountable. Therefore, we ask SSA OIG to conduct three separate investigations.

First, we ask SSA OIG to investigate the actions of Leland Dudek prior to his appointment as Acting Commissioner to review the information he disclosed, the individual(s) who received such information, and the method in which the information was transmitted. We ask that you respond in writing as soon as possible.

Second, we ask SSA OIG to investigate whether SSA violated federal privacy laws, including but not limited, to the Privacy Act of 1974, as amended, Section 1106 of the Social Security Act, and FISMA in authorizing DOGE, or any individuals or entities operating under the guise of or direction of DOGE (including such individuals who may have been onboarded to the Agency and received an Agency or Departmental email address) to access SSA databases that include personally identifiable information, wage or tax information, or personal health information. We ask that this investigation review whether, prior to providing systems access, these individuals:

- 1. Obtained security clearances commensurate with the data access requested;
- 2. Successfully completing the proper systems security, privacy and disclosure, and telework trainings; and
- 3. Obtained statutorily mandated signed acknowledgement agreements.

Third, we ask that you investigate reports that DOGE, or individuals operating under the guise of or direction of DOGE, accessed such information or SSA databases in unsecure locations, as prohibited by federal privacy and security laws, regulations, SSA policy, and OMB guidance. We ask that this investigation review their telework agreements (if any) and determine whether

any of their actions violated any federal laws, regulations, policies or guidance related to systems security, privacy and disclosure, and telework while working remotely.

Ms. Anderson:

We write today to request an investigation by the Social Security Administration Office of the Inspector General (SSA OIG) into reports that the Social Security Administration (SSA) is taking steps to place certain categories of immigrants who have lawfully obtained social security numbers (SSNs) in its Death Master File (DMF). This decision will result in the "financial murder" of living individuals improperly placed in the file, with everything from their credit cards and banking to their ability to access healthcare and housing being ripped out from under them. It is also a flagrant violation of due process rights enshrined in the U.S. Constitution, which protect citizens and noncitizens alike. We are alarmed that the Trump Administration appears to be trammeling the Constitution in a shameful attempt to purge immigrants from American public life.

As you know, the DMF is a record maintained by SSA of all deceased persons who had an SSN during their lifetimes. To date, the dataset contains records of more than 141 million people whose deaths were reported to SSA and contains each individual's name, SSN, date of birth, and date of death. As SSA has noted repeatedly—and as recently as two weeks ago²—the value of the DMF "lies in its accuracy and reliability." SSA does not submit death records to the DMF without running each record through a rigorous verification process. SSA vets each death record—including those submitted by state agencies—through its Death Information Processing System before adding the death record to the DMF, and rejects death reports that do not pass its verification checks.

This vetting process is rigorous because the results of erroneous placement in the DMF are catastrophic, as illustrated by recent news reports.³ If living number-holders are improperly transferred to the DMF, they lose their ability to legally work in the United States, as well as

access to their Social Security benefits, healthcare, banking and credit cards, and access to virtually every other exchange with a third-party that is verified by a valid SSN. The result is, as former SSA Commissioner Martin O'Malley put it, "tantamount to financial murder." Even when improper placement in the DMF arises from administrative error, the mistake is painfully difficult to remedy. But this purge of immigrants without diligence or due process is no mistake, and neither will be the catastrophic fallout in the lives of hundreds of thousands—it is this administration's express purpose. This move promises to upend the lives of people in this country with little chance of recourse and implicates numerous federal laws.

Numerous federal laws are implicated by this action, as well as bedrock constitutional rights. The Constitution prohibits the government from depriving any person, U.S. citizen and noncitizen alike, of their life, liberty, or property without due process. Under this requirement, the government must establish fair procedures that involve notice and an opportunity to be heard when it seeks to terminate a person's claim to property. The Supreme Court has recognized property interests in tangible and intangible property, including public benefits such as Social Security. The termination of a person's association with their SSN, as well as the resulting loss of tangible and intangible property, require full due process considerations. Additionally, the Privacy Act and SSA regulations require that living U.S. citizens' and Lawful Permanent Residents' information receive privacy protections against unauthorized disclosures. Because individuals are required to provide SSA with private personal information, all personal information stored in SSA systems is afforded protections exceeding the Privacy Act's protections.⁴ Because information transferred to the DMF is not treated with the same privacy protections under both the Privacy Act and SSA regulation, the removal of living persons, some of whom may be naturalized U.S. citizens or Lawful Permanent Residents, risks serious privacy violations.

In addition to these blatant rights violations, the action may violate federal law prohibiting the falsification of government documents.⁵ This prohibition has been applied to guard the integrity of government functions against misuse, and provides that employees of a U.S. agency or department are prohibited from knowingly and willfully falsifying agency records.⁶ Per SSA regulation, transfer of an SSN in the DMF may only occur in the case of the individual's actual death and generally requires evidence to substantiate it.⁷ As you know, the DMF—and more broadly, SSNs—are used by federal agencies, state governments, financial institutions, insurance companies, and dozens of other private sector industries for identification. By knowingly transferring the SSNs of living number-holders to the DMF, SSA employees effectuating the initiative may be liable for the deliberate falsification of federal records.

It is dangerous and shameful, and likely illegal, to alter government records held by SSA in order to "encourage [immigrants] to self-deport." This plan not only threatens the ability of immigrants who have lawfully obtained SSNs to live and work in the United States, but all Americans who may one day find themselves the target of this administration as it expands its

assault on all people and institutions standing in its way. It threatens the financial stability of targeted individuals and Americans who may be purged in error, the stability of all third parties who rely on SSN verification to conduct business, and the accuracy and reliability of SSA records. In light of these far-reaching implications, we are requesting a full investigation by SSA OIG which includes, but is not limited to, addressing the following questions:

- 1. Describe the determination process for transferring each individual living number-holder to the DMF under this new initiative.
 - a. How will each number holder's status be vetted and verified?
 - b. What third-party entities, such as states and other federal agencies, will SSA cross-reference to confirm its determination?
- 2. Who has the ultimate decision authority to transfer a living individual's SSN to the DMF?
 - a. Will SSA or an external agency be responsible for the final decision?
 - b. Which subcomponent at SSA will be responsible for producing recommendations to transfer individual SSNs to the DMF?
 - c. Which officer(s) at SSA will have the final decision authority to verify the subcomponent's recommendation?
- 3. What evidence does SSA require in the process of vetting a number holder for transfer to the DMF?
 - a. What is the standard by which SSA must be satisfied that relevant information proves an individual falls into a transferrable category?
- 4. What due process concerns is SSA considering?
 - a. Are individuals to be notified prior to removal to the DMF? If so, how are they notified?
 - b. Will individuals be given an opportunity to challenge SSA's determination prior to a final decision to transfer their information to the DMF?
 - c. Following an SSN being transferred to the DMF, will the individual previously associated with that SSN have the right to appeal the action?
 - i. If so, will this appeals process be handled judicially or administratively?
- 5. What is SSA's stated purpose of transferring living number-holders to the DMF without a determination that the number-holder has died? Under what statute, regulation, and subregulation provides SSA such authority?
- 6. What privacy considerations is SSA making regarding the information of living persons placed on the DMF?

- a. How will SSA ensure the Privacy Act's protections for living citizens and lawful permanent residents are upheld?
- b. How will SSA ensure SSA privacy regulations protecting the information of living citizens and lawful permanent residents are upheld?
- 7. What role do outside federal agencies, such as the Department of Homeland Security, play in carrying out the effort to place living number-holders in the DMF?
 - a. Was this effort established to achieve any outside agency ends?
- 8. Does SSA use appropriated funds through its Limitation on Administrative Expenses budget to administer this initiative? If so, are activities associated with this initiative reimbursed?
- 9. Please provide a copy of the Interagency agreement facilitating SSA's involvement in this initiative with DHS.
- 10. Please provide a copy of the Computer Matching Agreement between SSA and DHS entered into to facilitate this initiative.
- 11. Reporting indicates that SSA will be changing the name of the DMF to the "Ineligible Master File." Has this change already occurred?
 - a. How has this change been communicated to third parties that make use of the DMF?
 - b. In accordance with this new name and purpose, what information does SSA list for each entry of a living number-holder in the DMF?

Acting Commissioner Dudek:

We write to express our outrage over reports¹ that the Social Security Administration (SSA) have placed at least 6,300 immigrants—including children and seniors in their 70s and 80s—onto the agency's Death Master File (DMF) in an effort to have them "self-deport." This inhumane, illegal, and unconstitutional action will inflict—and already has inflicted—irreparable harm on these individuals, undermines trust in and accuracy of the Social Security programs, and sets a dangerous precedent in allowing the government to take away Americans' access to their earned Social Security benefits. We are further outraged that the Trump administration is directing SSA to continue efforts to eliminate immigrants' ability to live and work in the United States.

As you know, the DMF is a record maintained by SSA of all deceased persons who had an SSN during their lifetimes. To date, the dataset contains records of more than 141 million people whose deaths were reported to SSA and contains each individual's full name, SSN, date of birth, and date of death. SSA uses this data to administer the Social Security programs and to identify and reduce improper payments. SSA also shares the DMF with other federal agencies and state governments and sells a limited version to the public to prevent and reduce improper payments and combat fraud in their respective programs.

As SSA has noted repeatedly—and as recently as last month²—the value of the DMF "lies in its accuracy and reliability." SSA does not submit death records to the DMF without running each record through a rigorous verification process. If the death of an individual results in the potential entitlement of another person such as a spouse or a child, SSA vets each death record—including those submitted by state agencies—through its Death Information Processing System before adding the death record to the DMF, and rejects death reports that do not pass its verification checks. Indeed, SSA has resisted adding individuals to the DMF without having

evidence certifying the death³ and that the deceased's identifying information matches SSA's records.⁴

Until this initiative was reported, it was our understanding that SSA's priority was maintaining the DMF's accuracy by keeping living individuals out of the DMF to avoid inflicting irreparable harm on living individuals. If living number-holders are improperly transferred to the DMF, they lose their ability to legally work in the United States, as well as access to any earned Social Security benefits, healthcare, banking and credit cards, and access to virtually every other exchange with a third-party that is verified by a valid SSN. The result is, as former SSA Commissioner Martin O'Malley put it, "tantamount to financial murder." Changing the name of the database to the "Ineligible Master File" as a clumsy attempt to evade public criticism or legal exposure does not mitigate these consequences to these individuals, as has already been reported. But this purge of immigrants without diligence or due process is no mistake, and neither will be the catastrophic fallout in the lives of hundreds of thousands— it is this administration's expressed purpose. This move promises to upend the lives of people in this country with little chance of recourse and implicates numerous federal laws.

protections.⁷ Indeed, your own lawyers reportedly agree⁸ that this action violates the Privacy Act and that the agency is "knowingly and falsely declaring that living people are dead." In addition to these blatant rights violations, the action may violate federal law prohibiting the falsification of government documents.⁹ This prohibition has been applied to guard the integrity of government functions against misuse, and provides that employees of a U.S. agency or department are prohibited from knowingly and willfully falsifying agency records.¹⁰ The Privacy Act also requires agencies to ensure its records are accurate and complete to the degree "necessary to assure fairness to the individual[s]" whose information has been recorded.¹¹ Per SSA regulation, transfer of an SSN in the DMF may only occur in the case of the individual's actual death and generally requires evidence to substantiate it.¹² As you know, the DMF–and more broadly, SSNs–are used by federal agencies, state governments, financial institutions, insurance companies, and dozens of other private sector industries for identification. By knowingly transferring the SSNs of living number-holders to the DMF, SSA employees effectuating the initiative may be liable for the deliberate falsification of federal records.

In support of this initiative, the Trump administration has cited its interest in encouraging immigrants to "self-deport" by cutting off all access to financial subsistence. This stated interest, however, is not within the programmatic role of SSA to force immigrants to "self-deport". By co-opting SSA systems, personnel, and funding to serve an immigration enforcement purpose, SSA could be violating federal appropriations law for using appropriated funds for purposes for which they weren't appropriated.¹³

In addition to the serious legal concerns this action raises, it is also an affront to the value of immigrants to our society and to the program. Falsely declaring immigrants as dead, or otherwise eliminating their ability to use their legally-obtained SSN, will render them incapable of working legally and will inevitably push them into the shadows, forced to subsist in an underground economy. For many reasons, targeted individuals will be unable to leave this country. To be sure, numerous studies from the left and the right have shown immigrants have a net positive effect on our economy, directly contradicting the Trump administration's justifications for this initiative, but their whole contribution to our country cannot be quantified in mere dollars.

It is shameful to push immigrants to "self-deport" by illegally transferring their SSNs to DMF in blatant violation of the Constitution and numerous federal laws. This alone would be outrageous,

but the precedent it sets threatens the security of all Americans, citizens and noncitizens alike. We have observed over the course of this administration that President Trump widens the scope of his attacks the moment he successfully targets a particular group. After this administration ran roughshod over due process and court orders to confine immigrants to an El Salvador prison, the President publicly mused about the possibility of disappearing American citizens there next. If the president can trample the Constitution to target immigrants who have lawfully acquired SSNs, he will do the same to American citizens he wishes to target, and SSA will be complicit in those actions.

We are alarmed by SSA's actions to weaponize Social Security and in contravention of the Constitution and multiple federal laws. This shameless attempt to push immigrants who have lawfully obtained SSNs into the shadows threatens our community members and the bedrock freedoms and safeties upon which we all rely. The purpose of SSA is to provide for the welfare of number-holders and their dependents, not to serve as an arm of President Trump's immigration enforcement agenda. This move degrades the solvency, reliability, and accuracy of SSA systems and programs. It is as cruel as it is thoughtless—the impact will be felt in communities across the country and in the future of SSA programs themselves.

We urge you to immediately cease this practice and remove all individuals placed on the DMF through this initiative.
